SEMINARY EXTENSION

Rev. Victor King, Director

Seminary Extension at the McMinn Meigs Baptist Center is running full speed ahead. We completed the winter session with a study on "**Formation For Ministry**," using Aleshire and Knight's collection of essays, *The Minister and the Ministry*, and Richard J. Foster's *Celebration of Discipline*. This was a study of the meaning of ministry; some spiritual, some personal, and some professional requirements for ministry, as well as ways in which ministry may be expressed. With the major topics of spiritual discipline, vocational discernment, and theology of ministry discussed.

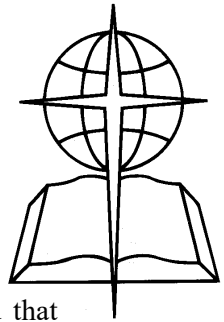
In the spring/summer session we studied "**Biblical Backgrounds**," using Thomas Brisco's, *Holman Bible Atlas*. This was a study of biblical events from the time of the patriarchs of the Old Testament to the era of the apostolic church, with emphasis placed on the world of the Bible in its historical context; including the political, social, and economic factors which influenced the people of the Bible.

The fall session, currently underway, is looking at the study of "**Romans**," using F. F. Bruce's *Tyndale New Testament Commentary: Romans*. This is a study of the book of Romans, which the writer tries to put Paul's thoughts in a language that can be more easily understood today. The basic objective is to gain an understanding of Paul's exposition of Salvation by Faith.

The current matriculation of the students is:

- Five are seeking a Diploma in Ministries/Pastoral Education or Biblical Studies
- One is currently Undeclared

I still want to challenge our churches to give \$100 each per year to Christian Builders. Many are giving the \$100, and some have given more. One of our churches gave \$800 this last year, which allowed us to purchase a generator that powers all our tools. With this, we do not have to enter a house to plug in for power and deal with tripped breakers. This also allowed us to get back to work building ramps during the COVID 19. We also accept donations from individuals.

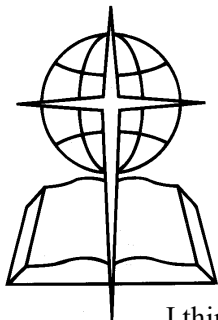
This year, we have seen several clients opt to pay for their materials. Sometimes clients can afford the materials, but not afford the labor to build a ramp. We still build these ramps free of charge for the labor we do. We have been blessed that some also gave a gift to Christian Builders.

We can always use more volunteers. If you can carry a board, we can use you. If you know how to run a saw or nail gun, we can use you. If you have a PhD (post hole digger degree) we can use you!

Lastly, please keep all of our clients, past, current and future in your prayers. Many times as I go to interview these people, they are dealing with medical issues, in pain, and depressed. Some tell me they used to go to church, but now due to their disability, they can't. And, they feel like their church forgot them. They need our churches to reach out to them. They are your neighbors.

DIRECTOR OF MISSIONS REPORT

I think most people can guess what is coming in this year's report. While things started off without a lot of changes, that quickly changed as spring approached this year. We have ended the year without having an annual meeting. We hope to reschedule that in early 2021.

The number one question to the DOM this year has been, "What do you think we should do?" More than a few pastors and church leaders have asked this question. I just wish I had better answers. Thanks also to our officers for the year, Vic King and Gene Guffey. They have proven themselves to be worthy leaders and wise counsel for me during all of this. I am grateful for their help and support during this year.

I also want to thank our Thursday prayer group. We missed a few weeks, but for the most part they have been faithful to be here and pray together each week. This has been a special time for all of us, and we would love to see a few more join in with us.

We keep looking forward to things getting back to normal. I do pray that we will be able to have camp next summer. With it closed this year, renovations have been ongoing and it will be nice to see the updated cabins put to use. Thanks to Mike Bernard for the years of service at Camp Cherokee.

By a mail vote of the Executive Board, the present budget and officers will continue until we are able to hold our annual meeting. We are posting the end of year financial reports in this newsletter so everyone can see them at this time. If you have any questions about these reports or other areas of association work, we will be glad to send you more details.

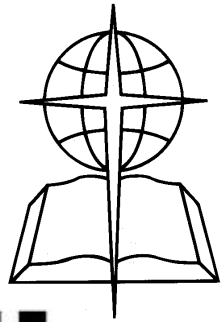
May our faith increase daily. May God continue to do His great works. May His kingdom increase. I look forward to seeing more happen in 2021.

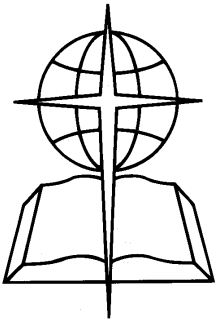

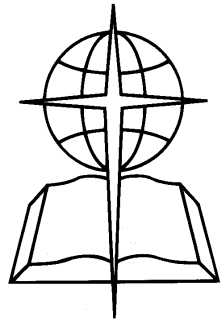

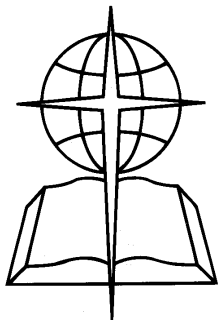

Committee Reports:

Stewardship Committee Report:

Rev. Van Elkins, Stewardship Director, presented the Treasurer's Report for the Association and for Camp Cherokee. The report was approved as printed.

Camp Cherokee Report:

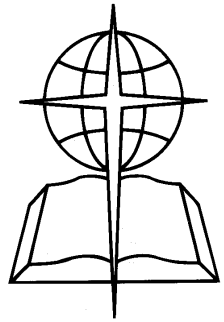
As Rev. Mike Bernard reported at the Annual Meeting, we had a group from West Tennessee that came out in October to do some much needed upgrades on the cabins. Now we need to finish! Around March, April and May we will be calling on our churches to finish this project before the summer months. We will need carpenters, electricians, painters, caulkers, etc. We will be getting a letter out to the churches letting you know the dates we will be working. We also need to work on getting underground power at the camp. Pray for the camp – and send your kids to camp this summer!

Director of Missions Report:

Rev. Mike Farmer, Director of Missions shared the following:

- Since our last meeting, I have participated in two Revitalization Training conferences and two Deacon Ordination Services. We recently lost one of our Retired Pastors, Rev. Max Redman and Mrs. Margie Davis, wife of retired Pastor Rev. Joe Davis. Please be much in prayer for Lovella Redman and Joe Davis during this time.
- Tax Conference – Just a reminder: If you are a Pastor of a church, you should receive a W2's. And all tax forms are required to be submitted to the IRS by January 31st. Contribution Statements must be received before anyone files their tax return – if they are going to itemize. Also, just a reminder that *anything* a church does for the Pastor (gift cards, money tree, etc.) is taxable income for the Pastor.
- Out of the Church Revitalization Conference, we now have a Church Revitalization Team in place for our Association. It consists of: Mike Farmer; Jim Perkins (First Baptist Athens); Toby Brogden (First Baptist Calhoun) and Bill Henard (First Baptist Athens).
- The Missions/Evangelism committee met together to discuss having an event that would attract a lot of people. What we are looking at is doing a crusade with Rick Gage/GoTell Ministries. Rick is often referred to as a "small town Billy Graham". He goes into the small rural areas and conducts crusades. He conducted a crusade in Morristown last year. It was a 4 night meeting with approximately 17,000 in attendance. Over 900 decision were made with 369 first time professions of faith. 7,000 people attended the last evening of the crusade with approximately half being students. We have talked with Rick and he is very interested in the possibility of doing something in our area. He has a very detailed check-list and the 1st step

is a check-out meeting. We (the Missions and Evangelism Committees) are recommending that we host a check-out meeting with Rick and our pastors and representatives from the churches. We will need a steering committee of approximately 12 – 15 people to oversee the whole process and it will take a minimum of 9 to 12 months preparation time, so we are looking at 2021 at the earliest. - Rev. Wayne Stowers, new staff member at East Athens Baptist Church has been involved in an organization called Child Evangelism Fellowship. This is basically a Bible club in elementary schools. He has spoken to McMinn County and Athens City Schools and they are both very open to allowing this. Basically what would happen is a church in the area of the school will adopt the school and provide that activity at that school. If your church would be interested in adopting a school in your area, please contact Wayne at East Athens Baptist Church.
- Disaster Relief Training on Thursday, January 30th here at the Association Office. We will have Introduction to Disaster Relief and Chainsaw Training back to back. Then on Saturday, February 1st, we will have the Spiritual Preparation class taught by Scott Duckworth. There is a \$36.00 fee – this covers your background check and is good for 3 years.

Other Reports:

Jordan Soto with Tennova Health System in Cleveland came and told us about the Behavioral Health program that they have. The program deals with addictions, suicidal thoughts, depression and anxiety. He left brochures and business cards if you know someone who has a need for this program. There are Christian therapists, chaplains and they also connect people to Christian organizations.

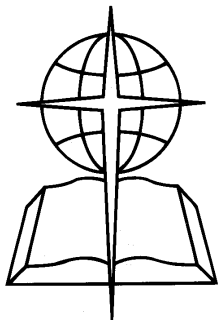

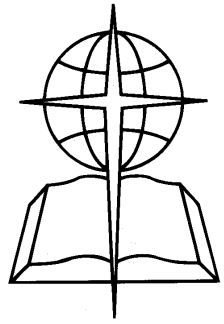

We are living in uncertain times. Churches, schools and work places are trying to navigate their way through things we do not understand and have never dealt with before. It is no different with the Association.

We had rescheduled the July Executive Board Meeting until August 18. With the numbers of virus cases still growing in our area, I discussed with the pastors at our Monday meeting today about what we should do about holding the Executive Board meeting. I know several have expressed the hesitancy to attend a meeting. I do understand the need to use caution and I do not want to pressure anyone into coming to a meeting they don't feel comfortable being at.

The general consensus was that we could have a hard time getting a quorum together. Some could meet online, but not everyone has that capability. Thus, we felt the best thing to do for the time being is to have a mail response to have a firm action on some matters that need to be addressed.

These items need to be voted on by the Association leadership. Our annual meeting scheduled for October 19 at Central Baptist Church obviously could be delayed with all the problems we have been facing. These recommendations are presented simply to take care of things until we are able to meet for an annual meeting.

The following recommendations are presented to you for your approval.

Recommendation 1: The Personnel Committee recommends Joe Delph, Associate Pastor at First Baptist Church Athens, as the Interim BCM director. Joe has a Ph.D. from Southern Seminary in Applied Apologetics, as well as two Master of Arts from Liberty Seminary and Southern Seminary. The Committee will recommend Joe be hired for the position at a time when we can gather and you have a chance to meet and hear from Joe himself.

Recommendation 2: All Leadership positions be continued as is if the Annual Meeting is delayed.

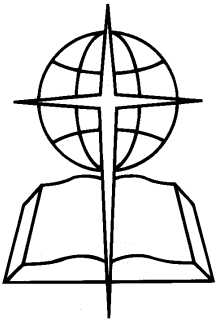
Recommendation 3: The Stewardship Committee recommends the current budget will continue if the Annual Meeting is delayed.

Recommendation 4: A request to change the Housing Allowance for the DOM to \$25,000 annually. This would be a readjustment of the Salary and Housing lines with no change in the cumulative total.

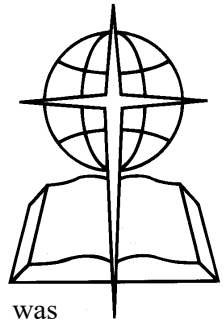

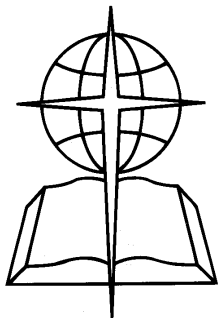

Thanks to each member of the Stewardship Committee who have served faithfully this year. We are grateful for your service.

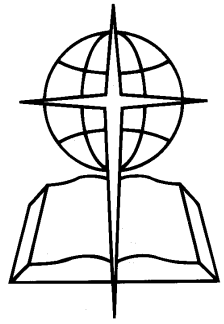

The *Baptist and Reflector* continues to strive to produce articles and columns that impact Tennessee Baptist Convention churches. As with the rest of the world, one of our major emphases in 2020 has been publishing articles to help our churches deal with the COVID-19 crisis in our country. In addition, just before the pandemic started to peak in March, we provided extensive coverage of tornado damage through Middle Tennessee and later in the Chattanooga-Cleveland area of East Tennessee.

Also this year, the *B&R* is focusing on our 185th anniversary as a Baptist state paper. The paper was established in 1835 by Editor R.B.C. Howell, who also was the pastor of First Baptist Church, Nashville. The first issue of *THE BAPTIST* was published on Jan. 1 of that year. The paper would eventually become the present day *Baptist and Reflector*. It is one of the longest, continuously published papers in the United States.

The *B&R* is mailed to more than 18,300 homes 26 weeks a year, reaching nearly 50,000 readers.

In addition, the *B&R* website has grown steadily since it was introduced in late 2015. From January through mid-July of this year we have had 167,300 visitors and 343,900 page views. The number of visitors is more than double what the website had at the same time last year and the page views have increased by more than 140,000 over the same time frame.

The goal of the paper is to “tell the story of Tennessee Baptists” through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics such as domestic violence that impact Tennessee Baptists and our churches.

The *Baptist and Reflector* continued to utilize social media tools in 2020 such as Twitter and Facebook. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers. The Church Trial Plan has been reintroduced. We need more churches to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the *B&R* for the next year to consider sending one subscription to someone they know. If just a small percentage of our readers would do this, our print circulation would significantly increase. 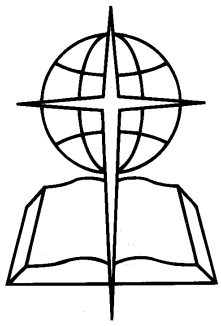

Highlights of the Foundation's stewardship thus far for this fiscal year include:

- **Funds under management: Over 1,100**
- **Assets under management: \$156,413,916 (as of May 31, 2020)**
- **New fund additions as of May 31, 2020: \$2,763,360 (11 new funds)**
- **Educational scholarships: 228 - totaling \$184,748 for 2020-2021 academic year. (Awarded over \$5.7 million in scholarships since 1987)**
- **Special Project Grants: \$118,300 distributed to assist 67 ministry projects thru May 31, 2020. This included helping 55 churches/associations during the Covid-19 pandemic and \$10,000 to Disaster Relief for tornado relief that affected Nashville in March.**
- **Cooperative Program: \$316,965 as of May 31, 2020. Projected to give over \$500,000 by year end.**
- **Baptist and charitable causes: \$1,945,310 as of May 31, 2020. Projected to give over \$3.3 million by year end.**

The Tennessee Baptist Foundation continues its commitment to manage funds with integrity and help Tennessee Baptists leave legacies with a Kingdom focus.

I am most grateful to report to you that we have not experienced a single case of Covid-19 at any of our locations! We have much to be joyful about in this regard. The 2020 Father's Day Offering video expresses my utmost appreciation and gratitude for the men and women who live out their calling to *Show What Love Is* by serving as our home managers. They are the ones to be credited for us weathering the Coronavirus storm.

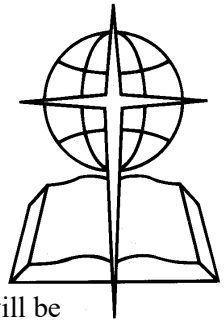
As a result of Covid-19 we have observed a quarantine in our homes for much of this fiscal year. The inability to accept new admissions, conduct placement interviews, allow visitors, or allow residents to visit their family homes has made this a very difficult year for everyone. Our faith is that, in the long run, our efforts will prove well worth the struggle. One case in any facility will have a cascading effect so we developed plans for each individual resident should anyone contract the virus. Each individual plan is designed according to the family and other resources an individual has at their disposal. We call them "the plans we plan to never use."

I am happy to report that we have sold Williams Ferry Pointe in Lenoir City. The transaction took place in a series of closings from June to October 31, 2020. The sale price for WFP was \$2.7M. These much-needed resources will be used to help us realize a **two-fold vision**.

First, it will allow us to establish a significant endowment that will produce operating income. Our Father's Day Offering has never managed to rise to a level to offset our operating deficit.

Secondly, it is our hope to establish a small senior living community in Humboldt on land we already own where we can provide modest, comfortable retirement living (probably duplexes) for indigent pastors and missionaries who may not be financial able to provide from themselves

in retirement. TBAH will own these facilities and rent them on a sliding scale basis. They will be for independent living seniors; we will provide no health care or physical assistance. And, it will be a TBAH in west Tennessee!!

Covid-19 and the sale of Williams Ferry Pointe guaranteed that this past year was not, and next year will not be, ordinary. I am confident, however, thanks to the resources from the sale of Williams Ferry Pointe coupled with the elimination of all expenses associated with the operation of Williams Ferry Pointe, TBAH will be OK through the pandemic and for the foreseeable future. Thanks be to God for his provision!

Thanks, again, for your support and partnership with us. May you all be safe and stay well.

We are committed as a ministry to operate without the use of government funds relying on God's people to supply the resources necessary to meet the needs of children and families in crisis.

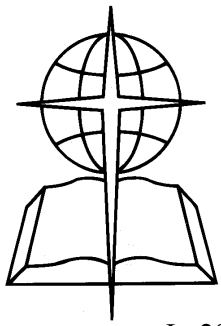
2020 has presented many challenges for all of us. We have lost hundreds of volunteer man hours due to COVID-19. And while the number of churches that support us financially has dropped significantly, other churches have stepped up in their support of the kids. All in all, the Lord has shown His faithfulness to this 129-year-old ministry by providing the necessary resources for us to provide homes for children. We rejoice in the five children who have been born again. Rest assured that TBCH is Christ centered in our approach to dealing with children and their families. We believe Jesus is the ultimate answer to all brokenness and our team unashamedly points people to Him in age appropriate ways.

TBCH has provided **Residential Care** for 85 children so far this year in our on-campus homes. Seventeen of these children have been successfully reunited with their families. TBCH is also committed to assisting those who age out of our program. These **Independent Living** students now transition to our Chattanooga Campus where they receive continued support by our staff and have the opportunity to learn a trade or attend college. We are committed to helping these young people get off to a good start in early adulthood. There are presently ten young people in our Independent Living program.

TBCH's **George Shinn Foster Care** program has served 157 children and has 101 foster homes on our team. Fifteen children have been adopted into Christian families so far this year while 31 children are presently in foster-to-adopt situations! Our foster care staff has also seen 15 children successfully reunify with their families.

The foster home in Oakdale is very close to being ready for children to arrive while our foster home in Kingsport is nearing the completion of being remodeled. We are just beginning the search for a family to live in this home who has the heart for caring for sibling groups of foster children. TBCH is grateful for the churches and volunteers who are helping bring this home back into service!

TBCH's **Family Care** program exists to assist families as they deal with things like addictions, child abuse, and the need for faith-based foster homes. We want to help families learn to cope and find the answers they need by providing consultation and resources. We are also ready to provide training for your church in child abuse awareness and in how to support your own foster and adoptive families. Please call on us and we will be there to help you help children.

In 2019-20, Tennessee WMU continued to challenge Tennessee Baptists in their unshakable pursuit to know God more, show His love unconditionally, and make disciples who make disciples. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Last fall, 698 children and leaders attended three regional JAMs, a missions event for children in grades 1-6 and leaders. Children learned what it means to go everywhere and tell the Good News to everyone, they met missionaries from around the world, and they collected 149 Christmas Backpacks. Over 500 boys and leaders attended the 2019 RA Camp-O-Ree at Linden Valley Baptist Conference Center on October 18-19. This missions camping event for boys grades 1-12 is hosted by Mid-South Royal Ambassadors and Tennessee WMU. Boys participated in a multitude of activities, challenges, and crafts while enjoying the great outdoors, meeting missionaries, and enjoying two action packed worship services.

Missionary Parents Fellowship Retreat: On September 6-7, 2019, 40 parents of IMB missionaries gathered with program personnel for fellowship, information, prayer, and encouragement at the TBMB Church Support Center in Franklin. The retreat attendees were encouraged to return to their churches and thank them for their support of the Tennessee Missionary Parents Fellowship through gifts to the Golden Offering for Tennessee Missions.

Christmas Checks – In December 2019, Tennessee WMU mailed Christmas Checks, on behalf of Tennessee Baptists to missionary kids and retired missionaries.

- Checks for \$150 were sent to 20 missionary kids whose parents serve with IMB from Tennessee.
- Checks for \$50 were sent to 104 retired IMB missionaries born in Tennessee.

These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.

In the Spring of 2020, concerns about Covid-19 virus were growing and several 2020 events had to be cancelled like Get-Together & Connection, Tennessee WMU Annual Meeting, and RA Wilderness Challenge. Out of the challenges and changes arose some new ways to utilize digital resources:

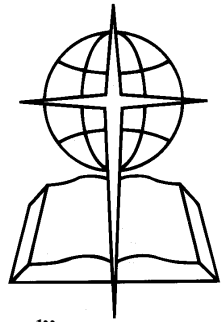
- Zoom with a Missionary – scheduled Zoom meetings with missionaries and children/youth missions discipleship groups hosted by Tennessee WMU.
- LeaderConnect – Zoom meetings for missions and ministry leaders for training and networking.
- Facebook Pages and Groups – New Facebook groups were started for targeted missions and ministry leaders to coincide with efforts to utilize all Tennessee WMU Facebook groups and pages to network and resource leaders and participants more.

In March 2020, \$34,200 in scholarships were awarded to 29 students attending graduate school, seminary, as well as, undergraduate schools in Tennessee during the 2020-21 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

As part of Tennessee WMU's Denver Prayer Advocacy Partnership, over the past three years, 24 ladies have served through six mission teams to Denver. The teams worked with 14 different church planters to prayer walk and engage the communities surrounding the church plants. The two teams scheduled to go in April and May of 2020 had to be cancelled. In June, we partnered with Dave Howeth, NAMB Send Denver Missionary to host three virtual prayer walking tours. Each virtual prayer tour was two hours and participants heard from and prayed for four church planters. There were 47 total participants from 41 churches who participated in one or more prayer tours.

MK Re-Entry Retreat –Two missionary kids from Tennessee were provided travel assistance funds to attend the MK Re-Entry Retreat in Indiana during August 2020 hosted by Indiana WMU, Kentucky WMU, and the International Mission Board.

Literacy Missions ministries are helping bring Tennesseans to Christ. There are 68 "registered" churches/associations English as a Second Language (ESL), Adult Reading & Writing (ARW), or Tutoring Children & Youth (TCY) ministry sites. These sites reported having participants from more than 25 countries, speaking 11 different languages who are being taught English and are engaged with the gospel.

Christian Women's Job Corps and Christian Men's Job Corps are ministries of WMU that seek to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. Last year the 21 sites in Tennessee reported serving 2,855 participants. There were 182 men and women who completed the program and 32 recorded professions of faith.

Missionary Houses in Mt. Juliet – Mary's House (WMU House) and the Missions Mobilization Center (MMC) House continue to be a hub of activity as they provide a place for our missionaries to rest and reconnect with family and friends. The Worthy family arrived at Mary's House in June 2020 and will stay through May 2021. Frank & Sheri Moran arrived at the MMC House in April 2020 and will stay through October 2020 unless they receive clearance sooner to return to the mission field; delay due to Covid-19 restrictions.

The theme for the 2019-20 Tennessee Missions Emphasis was "See Tennessee, Go Harvest." The suggested dates for the Week of Prayer for State Missions were September 13-20, and the goal for the 2019-20 Golden Offering for Tennessee Missions was \$2,100,000. As of July 23, 2020, the total amount given to the 2019-20 Golden Offering is \$1,859,608.48. The offering year goes from September 1 – August 31.

BAPTIST MEMORIAL HEALTH CARE SYSTEM MEMPHIS, TENNESSEE

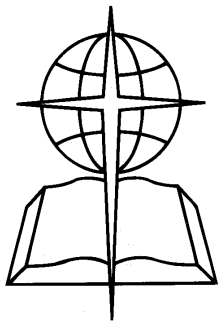

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough – at one point, it almost closed – but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines.

BAPTIST MEMORIAL HEALTH CARE SYSTEM MEMPHIS, TENNESSEE

In August 2017, Baptist's Pastoral Care Department introduced the Rev. Jimmy Terry Preaching Series: It's All About Jesus. The series is named in memory of a beloved member of Baptist's Board of Trustees and the founder and former pastor of Tabernacle Baptist Church in Clarksville, Tennessee. Each month, a speaker – usually an ordained Baptist minister – delivers an evangelical message to employees, physicians, patients and visitors at Baptist's flagship hospital. The message is also broadcast to all 22 of Baptist's hospitals in Tennessee, Mississippi and Arkansas, and it is promoted on Baptist's Facebook page.

In the last half of 2019 and the beginning of this year, hundreds of people attended Jimmy Terry Preaching Series sermons in our Garrett Auditorium and hundreds more watched on monitors throughout our health care system. We post a video from each event on our Facebook page, and from June 2019 to February 2020, those videos have been viewed nearly 79,000 times and have reached more than 82,000 people.

Baptist Memorial Health Care has dedicated a considerable amount of time and resources to protecting our communities from COVID-19. Since the pandemic began, we have treated thousands of COVID patients in our hospitals and performed more than 160,000 tests. In addition, we launched a multi-phase public education campaign that included television public service announcements, billboards, social media ads and posts, videos and media interviews. Hundreds of thousands of people received important information about the virus and how to stay safe and healthy. We will continue this necessary work for as long as COVID-19 affects the people we serve.

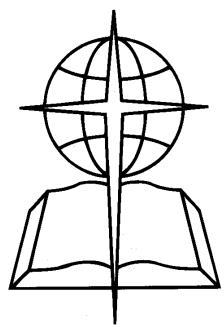
The Center of Excellence for Addiction Medicine, a partnership between Baptist Memorial Health Care and Integrated Addiction Care (IAC) Associates – a medical practice that treats patients with addictions to drugs and/or alcohol – won a \$4 million, five-year Health Resources and Services Administration grant to expand its addiction medicine fellowship program. The fellowship program is one component of the Center of Excellence, and it focuses on training future addiction medicine physicians. The grant will allow the center to train five physicians a year for five years, adding 25 addiction medicine specialists to the Mid-South community.

Generous Baptist team members helped raise \$133,000 during the 2019 United Way Giving Campaign. The money will benefit the United Way Fund, the Baptist Memorial Health Care Foundation and other charities. Funds help provide grief support, financial assistance for patients and employees, health care for the homeless, scholarships for students training to be health care professionals and many others in the communities we serve.

Using data from the College Scorecard, an online database started in 2015 to give more information about colleges, Georgetown University published a report that ranks 4,500 colleges and universities by return on investment. Baptist College of Health Sciences was the number 1 private college in Tennessee and was in the top 10 percent of colleges nationwide.

In September, the Baptist Cancer Center was one of only six centers in the country to begin a research study called the SIMPRO Research Center. In collaboration with the National Cancer Institute and the Beau Biden Cancer Moonshot Initiative, the study will help researchers and technicians develop, implement and evaluate an app called eSyM. The app makes it easier for cancer patients to track and communicate their treatment symptoms to their care team.

Baptist Memorial Hospital-Tipton won a Breastfeeding, Early Elective Delivery Reduction and Safe Sleep for Tennessee Babies (BEST) Award for its efforts to reduce infant deaths in the state. The Tennessee Department of Health and the Tennessee Hospital Association bestowed the honor, which promotes safe sleep for infants and helps give Tennessee babies a great start to life.



HARRISON-CHILHOWEE BAPTIST ACADEMY DBA THE KING'S ACADEMY

Harrison-Chilhowee Baptist Academy celebrates 140 years as a distinctively Christian school. For the past 26 years, Tennessee Baptist's accredited Christian boarding and day school has operated as The King's Academy. During this recent period enrollment increased 400% and the school budget grew to \$6 million. International students are the academy's most distinctive feature—over 1,050 students from 99 nations enrolled since 1935; an average of 14 countries are represented in the academy student body each year.

The academy faces increasing financial challenges each year, and these difficulties will be further amplified by the COVID-19 pandemic. Staff reductions and major budget cuts were necessary to remain operational for the 2020-2021 school year. Given the socio-economic demographics of academy families, increases in fees translate into enrollment declines, particularly to families who suffered income or job loss due to the pandemic.

Nevertheless, the academy remains focused on its VISION – *Transformed Lives, Empowered by Christ-like Character, Pursuing Academic Excellence and Lifelong Service* – and committed to its MISSION: *The King's Academy inspires and equips students of all cultural backgrounds to fulfill their God-given potential in a nurturing, college preparatory community.*

Matthew Mercer entered his second year as President/Headmaster for the 2019-2020 school year and added many new key staff members to enhance both faculty and administration. The academy experienced significant growth in its international boarding population, largely due to a partnership with WESPN, which assists in connecting students from Brazil and other South American countries with the academy. Approximately 70 students lived in the academy's dormitories for the 2019-2020 school year.

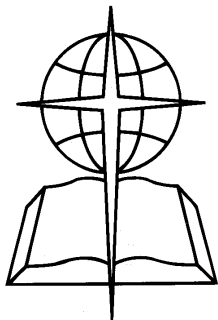
The COVID-19 pandemic brought great challenges. Academy students and staff were on spring break, when the academy's board and administration heeded federal, state, and local recommendations to close campus for in-person instruction. Students and staff were unable to have their usual end-of-year celebrations: field day, class programs, baccalaureate, promotions, etc. Thankfully, through the academy's 1-to-1 initiative, implemented for the 2019-2020 school year, every student in grades 6-12 had their own Chromebook for online learning to complete their academic coursework. Devices were also available for younger students who requested access.

Many of the academy's international boarding students were unable to return to their home countries during the COVID-19 shutdown in March, so they remained on campus to shelter-in-place together. These students received round-the-clock care and ministry from the academy's Resident Life, Food Service, and Maintenance Staff as well as online instruction from academy teachers. While it was a hard time to be away from their families, these students from all over the world bonded as their own unique family unit, creating life-long memories through their shared experience.

Prior to transitioning to online learning, highlights of the 2019-2020 school year include:

- Hosted Social Media Awareness & Responsibility Training for Parents, led by Security Officer David Whaley
- Hosted Elementary STEM Night
- Choir/Drama Department presented *Mary Poppins, Jr.*
- Students participated in annual Speech Contest, Spelling Bee, Geography Bee
- High School Volleyball team competed in TSSAA State Tournament
- High School Girls Basketball finished as runner-up in the TSSAA State Tournament Championship

We fulfill that transformational mission through our commitment to four core values: Excellence-driven, Christ-centered, People-focused, Future-directed.

These values shape our identity as an institution that prioritizes liberal arts-based undergraduate education, enhanced by professional and graduate programs. The Union academic community is composed of quality faculty, staff and students working together in a caring, grace-filled environment conducive to the development of character, servant leadership, and cultural engagement.

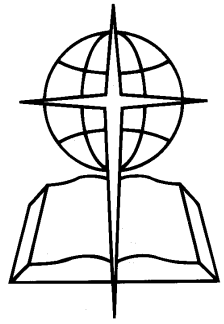
We saw many examples of God's faithfulness to Union during the 2019-2020 academic year. Our trustees approved a campus master plan that will guide development of Union's physical campus over the next 20 years. A survey conducted by our Vocatio Center for Life Calling and Career showed that 98 percent of Union's class of 2019 were employed or enrolled in graduate school within six months of receiving their degree. The class of 2019 in our College of Pharmacy received a 100 percent pass rate for first-time attempts on the North American Pharmacist Licensure Examination. Union was one of only three pharmacy schools in the nation to achieve that (out of 140 schools total), and the only one in the Southeast to do so.

In addition, we announced several new majors that will begin in the 2020-2021 academic year, including cybersecurity, criminal justice, forensic science and commercial music.

While the COVID-19 pandemic disrupted much of our spring semester, the Lord provided for our needs. We were able to hold commencement ceremonies in June to celebrate our 2020 graduates, and we resume our in-class instruction for the fall semester.

We are pleased to be partners with the churches of Tennessee Baptist Mission Board and are immensely grateful for their support. Because of the generous support of Tennessee Baptists, Union is able to provide a transformative experience for our students. As Union University strives to be faithful to our mission in an age when traditional Christian beliefs are continually under assault, we value the ongoing prayers and support of our Tennessee Baptist partners.

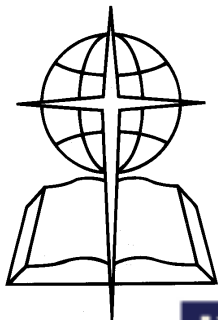
Charles A. Fowler, President

Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders.

This past year has included:

- The campus community began the year celebrating the University's new president Dr. Charles A. Fowler and his wife Sandra. The University held his inauguration where more than 40 academic institutions, associations and learned societies were represented. Inauguration events leading up to the ceremony featured speakers that included Dr. David Dockery, Dr. Tom Elliff and Dr. Randy Davis.
- Carson-Newman announced its largest freshman class in its history (557). It also marked its highest enrollment ever with 2,725 students and a record 885 graduate students.
- Partnering with the TBMB, C-N hosted "Tennessee Evangelism Rally," which drew more than 900 attendees from multiple churches across East Tennessee. The event featured Christian recording artist Christy Nockles, C-N alumnus Roc Collins and Christian music's Citizen Way.
- Baptist Collegiate Ministries (BCM) sent out 119 student missionaries and conducted nine mission experiences serving in 10 states and Mexico. These included Chattanooga's Tennessee Baptist Children's Home and "MissionLab" sponsored by New Orleans Baptist Theological Seminary. Twelve salvations were seen through these mission experiences.
- During the fall, the Eagles football team saw over 25 students make decisions for Christ.
- Now in its 36th year, C-N's Appalachian Outreach home repair ministry completed 16 home repair projects in surrounding counties. Its Samaritan House shelter served 29 families from four counties and provided 7,801 meals. The ministry continues to provide numerous meals to families in need during the COVID-19 pandemic.
- The University opened the "Randall O'Brien Veterans Center," which provides a gathering and relaxing space for students, faculty and staff who are veterans.
- Carson-Newman was championed by various rankings including being named a "Best in the Southeast" by Princeton Review and cited a "Christian College of Distinction" by Colleges of Distinction for the sixth consecutive year. The University was named among "Great Colleges to Work For," which was overseen by ModernThink. C-N's online graduate program was ranked No. 2 in the state by U.S. News & World Report. Its registered nursing program was named a top ten program in the state by Registered Nursing.org.
- Carson-Newman's Nursing Department held "Blessing of the Hands" ceremonies during the fall and spring. The event allows faculty members to pray over nursing students prior to them entering clinical care and hands-on patient care.
- The University's Baptist Archives received the Davis C. Woolley Award for Outstanding Achievement in Assessing and Preserving Baptist History. The honor was presented by The Baptist History and Heritage Society and the Association of Librarians and Archivists at Baptist Institutions.

Highlights presented here are possible because of the cooperation of Tennessee Baptists. Some programs, like certain mission trips, are made possible by the underwriting of individual like-hearted supporters.

At the North American Mission Board (NAMB), it's all about the Gospel. Everything we do is to help churches and believers share Christ in their communities, North America and around the world.

There were many highlights in 2019 as we served Southern Baptist pastors, churches and associations, but we want to start by thanking all those who gave so generously to the Annie Armstrong Easter Offering®. Southern Baptists gave a record \$61.6 million to the offering, an all-time high.

Pastors are NAMB's number one customer. We are here to serve them and help them succeed as they minister on the front lines. We serve pastors and churches in two primary ways: [Send Relief](#), our compassion ministry arm, and [Send Network](#), our church planting network. In addition to these two primary ministry areas, NAMB's Evangelism and Leadership Group, led by Johnny Hunt, exists to equip pastors and mobilize Southern Baptists for evangelism.

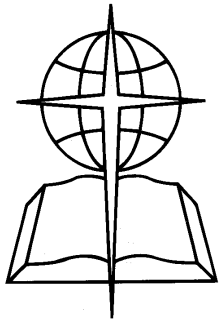
NAMB's Send Relief ministry is bringing help and hope to those most in need. Our Puerto Rico rebuild effort hosted hundreds of volunteers as residents continue to recover from Hurricane Maria, which struck in 2017.

Send Relief is giving churches the opportunity to serve in areas such as poverty, refugees and internationals, adoption and foster care, human trafficking and crisis response. We now have seven Send Relief ministry centers (Appalachia, Atlanta, Las Vegas, New Orleans, New York, Pittsburgh and Puerto Rico) that are meeting needs in specific regions and giving Southern Baptists from all over North America opportunities to serve in long- or short-term settings.

Here are a few highlights as we look back on the previous full year of ministry:

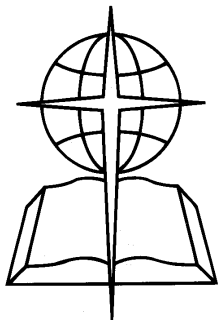
- Thanks to Southern Baptist giving, we are able to resource and support nearly 6,800 missionaries and chaplains. These men and women serve in difficult places and in challenging cultural contexts and many have left behind all that is familiar so they can tell people about Jesus.
- Southern Baptists added 908 new congregations in 2019, the most recent year for which data is available. This includes 552 new church starts, 59 new campuses and 297 new affiliations. We praise God for these new churches that are now part of the Southern Baptist family.
- Churches started since 2010 now account for 11 percent of all churches in the SBC and they report 18 percent of all SBC baptisms. Church plants are reaching people for Christ, and they are a positive force in our Southern Baptist family.
- Reversing the decline in baptisms won't be accomplished by a national entity, but we are making multiple evangelism resources available free to churches and emphasizing the annual SBC Baptism Sunday. We want to help Southern Baptists maintain evangelism and baptism as the top priority.

What is a Baptist Association?

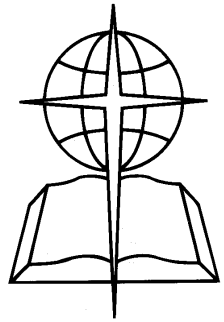
(An Association is what the churches make it.)

A Baptist Association is a self-governing fellowship of autonomous churches sharing a common faith and active on mission in their setting.

1. The churches of an association are free, independent, self-governing, autonomous churches that decide to associate themselves to do certain things together.
2. The fellowship of churches involves oneness, shared life, mutuality and koinonia. It is a “family” of churches and a network, in which churches give and receive assistance. The association as a fellowship emphasizes the relationship existing among the churches.
3. Sharing a common faith - The fellowship of an association is grounded in harmony in faith and practice. Associations differ in regard to the particular doctrinal issues that are important to their fellowship and in regard to the amount of diversity encouraged or tolerated on those issues. Nevertheless, the association, unlike state conventions, is a doctrinally based fellowship.
4. Active on mission refers to God’s mission for the churches individually and the churches together in association. The first responsibility of each church is to deal with the same question, “What is God’s mission for us together?”
5. In their setting deals with everything anyone means when he or she says of his or her association, “But I am in a peculiar situation.” Every situation is peculiar, that is, unique; and it is in the uniqueness of that situation that an association of churches has a very special responsibility to be on mission. Associations differ from one another in such ways as size; geographical territory; population; cultural, ethnic, religious, socioeconomic and demographic characteristics of the area; number, strength and types of churches; history; relationship to the state convention; and stage of development.
6. Self-governing - An association is created by the churches and is accountable to those churches through the messengers. An association, like other general bodies of Baptists, (state conventions, Southern Baptist Convention), is self-governing.

A Baptist Association is what the affiliated churches decide to make it. The messengers and executive board members selected by the churches make those basic decisions. The churches decide again what their association will become when they decide what percentage of their church budgets will go to associational missions.

Southern Baptists are committed to Bold Mission Thrust in a general way. You can be a part of what’s happening in a specific way through involvement in your church and association.

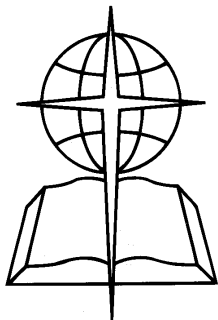
**McMinn-Meigs Association of Baptists,
Incorporated**
BY-LAWS

Article I – Existence, Purpose and Relationship

- Section 1:** The McMinn-Meigs Association of Baptists, Inc. exists because Southern Baptist Churches have chosen to join together in fellowship, evangelism and missions.
- Section 2:** The purpose of the McMinn-Meigs Association of Baptists, Inc. is to equip, resource and encourage one another to be faithful Kingdom Servants in obedience to our Lord's Great Commission.
- Section 3:** The McMinn-Meigs Association of Baptists, Inc. shall maintain a cooperative relationship with the Tennessee Baptist Convention and the Southern Baptist Convention in a world mission program.

Article II - Voting Body

- Section 1:** This Association in session shall be composed of messengers duly elected by the Southern Baptist Churches in McMinn and Meigs Counties who are affiliated with this organization. The affiliated churches shall be those that choose or elect to cooperate with the principles and practices of the Association as set out in the Charter of Incorporation and as herein set out.
- Section 2:** Each church shall be entitled to two messengers and one additional messenger for each fifty members or fraction thereof after the first hundred with a maximum of ten messengers from any one church.
- Section 3:** Any church petitioning for membership in the Association shall make such petition through the Credentials Committee. Each church whose petition is approved by the Association shall then be placed under the watch care of the Association for one full year or until the next annual session of the Association. At that time, and providing the church has proven to be in sympathy and in accord with the tenets and practices of the Association, it shall then, by a majority vote of the association messengers present and voting, become a member in full standing. During the year of watch care, the petitioning church shall have a voice but not a vote in Associational affairs, including the representation on the Executive Committee and messengers to the Association.
- Section 4:** As a condition of membership in the Association, member churches shall subscribe to the Articles of Faith as outlined in Article III. In addition, member churches are strongly encouraged to submit an annual church letter that will provide demographic information on the ministry and health of the church and contribute to the financial support of the Association.

A. Articles of Faith

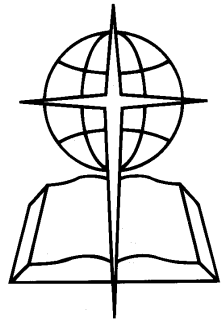
- 1) If any member of the Executive Committee feels that an affiliated church is in violation of any section of the Articles of Faith, said member should follow the guidelines of Matthew 18:15-17.
- 2) Should members of the Executive Committee, representing a minimum of two affiliated churches, believe that an affiliated church is in violation of the Articles of Faith, said members, after having, individually, followed the provisions of sub-Paragraph a of this Paragraph, shall bring the violation to the attention of the Association Officers. The Association Officers shall direct the Credentials Committee to investigate the charges brought against the member church, following these guidelines:
 - a) The Credentials Committee shall contact the church charged with a violation of the Articles of Faith in an effort to confirm the validity of the charges brought against the member church.
 - b) Should the Credentials Committee confirm the validity of the charges, every effort shall be made to lead the church back into conformance with the Articles of Faith and restore the church to fellowship with the Association.
 - c) Should the efforts of the Credentials Committee outlined herein fail to resolve the issue, the Committee shall present a report along with recommendations concerning membership to the Association at the next annual meeting or a special called meeting of the Association called for the expressed purpose of dealing with this issue. No such action shall be taken without at least 14 days written notice to all affiliated churches.
 - d) A recommendation for the loss of membership from the Credentials Committee shall require a two-thirds majority vote of the messengers present and voting at the meeting in which said recommendation is presented.

B. Re-admission

Any church dropped from the rolls, as a result of Section 4, may thereafter petition for re-admission under all the terms and conditions herein above prescribed for admission of churches to membership.

Section 5:

If any member of the Executive Committee feels that fellowship should be withdrawn from any affiliated church for any reason not listed above, said member should follow the guidelines of Matthew 18:15-17. If it is, thereafter, deemed necessary, by the Association Officers, to withdraw fellowship from any church FOR ANY REASON OTHER THAN THOSE SPECIFIED IN SECTION 4, and to refuse to seat its messengers, such action shall be only by a two-thirds majority vote of those messengers present and voting at any annual meeting or special called meeting of the Association called for this expressed purpose, exclusive of the messengers from the said church. No such action shall be taken without at least 14 days written notice to all affiliated churches.

Article III -Articles of Faith

The currently adopted Southern Baptist Convention version of the Baptist Faith and Message shall be the doctrines adopted by this Association.

Article IV - Authority

Section 1: The Association is an autonomous body and therefore reserves the right to determine its own policies and direct its own business; it may refuse to seat messengers who are not in fellowship or doctrinal agreement with the body or if the church by whom they are elected is not.

Section 2: The Association may advise, give counsel, and propose measures to the churches, but shall exercise no power or ecclesiastical jurisdiction over the churches. It shall have power, however, to withdraw fellowship from any church that departs from the doctrines and practices of Baptist Fellowship in accordance with the guidelines of Article II, Section 4.

Section 3: A church shall be considered a Southern Baptist Church in good fellowship with the Association if said church accepts and follows the Baptist Faith and Message referenced in Article III hereof as well as the conditions identified in Section 2 of this Article.

Section 4: Any question concerning fellowship with the churches shall be referred to the Credentials Committee for review in accordance with Article II, Section 4 (A) before presentation to the Association.

Article V – Meetings

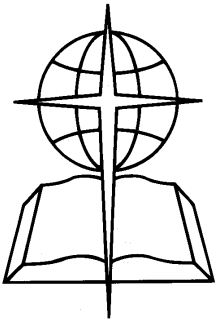
Section 1: The Association shall convene annually in the Fall for the annual business session, unless otherwise fixed by the Association in annual session. The Association may also come together in the spring for an Association Celebration emphasizing Evangelism and Missions in one special event.

Section 2: Special Meetings: The Executive Committee of the Association may call the Association into special session at a time and place set by the committee, with the provision that all affiliated churches must be notified in writing at least 14 days before the special meeting, said notice to give the time, place, and purpose of the meeting.

Section 3: The program for all Meetings shall be planned by the DOM and Association officers with the assistance of an ad hoc committee as necessary.

Article VI - Associational Year

The Associational year shall begin on October first and end on September thirtieth.

Article VII – Officers

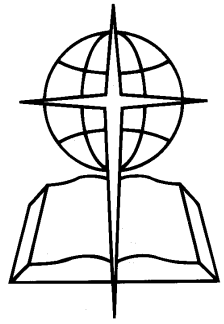
Section 1: The officers of this Association shall be a moderator, an associate moderator, a clerk, a treasurer, and such other officers as may be authorized by the Association. The moderator of the Association shall have the same duties as the president of a corporation is generally understood to have. The moderator and the associate moderator shall not serve for more than one consecutive year, and provided further, that no person shall be eligible for election as moderator until he shall have been a member of the Association for a period of two years. Furthermore, one of the offices, moderator or associate moderator, must be filled by a bi-vocational minister or a layperson. The retiring associate moderator shall be eligible for election to the officer of moderator. The clerk and the treasurer shall be employees of the Association.

Section 2: The officers shall be elected at the annual meeting by majority vote of messengers present and voting, and shall take office at the close of the annual meeting. They shall serve until the close of the next annual meeting of the Association, or until their successors are elected and installed, provided, however, that the retiring clerk shall continue in office as association clerk until the completion and publication of the Associational Minutes and completion of any other duties connected with his/her office for the past associational year.

Article VIII - Executive Committee

Section 1: There shall be an Executive Committee of the Association which shall consist of the following: one lay member elected by each church of the Association from its membership; the Director of Missions, director or chairman of all organizations and committees authorized by the Association; and the pastors of all churches in the Association. The moderator, associate moderator, clerk and treasurer shall be ex-officio members of the Executive Committee. The Executive Committee shall meet quarterly at the Baptist Center, 350 North Congress Parkway, Athens, Tennessee, or at such other place as may be previously determined. The Annual meeting will serve as the meeting for the fourth quarter of the year of the Executive Committee. The Executive Committee shall also meet at the call of its chairman. Twenty members of the Committee representing a minimum of 10 member churches shall constitute a quorum necessary to transact business. At its third quarter meeting preceding the Annual Session of the Association, the Executive Committee shall select the director of all organizations which may be authorized by the Association and as nominated by the Nominating Committee. The organizational directors so selected shall take office immediately following the next annual session. However, following the selection by the Executive Committee, the newly selected organizational directors shall be asked to recommend, to the Committee on Committees, the members for their respective committee/organization for the ensuing year.

Section 2: The pastor of any church organized as a result of a mission operated for not less than two years under the sponsorship of a church affiliated with the Association shall be a special member of the Executive Committee, with voice but no vote, until such times as said church shall have an opportunity to apply for and become affiliated with the Association.

Section 3: The officers of the Association are to be the officers of the Executive Committee, with the moderator of the association serving as chairman. The officers of the Executive Committee shall meet to plan the agenda for each Executive Committee Meeting. This meeting shall occur with sufficient time to notify the members of the Executive Committee of the pending business for the upcoming meeting.

Section 4: The purpose of this Committee shall be to care for every interest of the Association and direct its activities in the interim between the annual meetings and shall carry out the policies and will of the Association as so expressed. The Committee shall have power to fill vacancies, as nominated by the Nominating Committee, among the officers of the Association and the Board of Directors or committees which may occur during the year except representatives to the Executive Committee and may authorize the appointment of any special committee deemed needful to carry out its duties.

Section 5: Nothing outside of or beyond the authority given by the Association to the Executive Committee shall be exercised, unless prior written notice of at least thirty days has been given all of the churches of the Association and the members of the Executive Committee, with the opportunity for any member to present his views to the vote of the Committee.

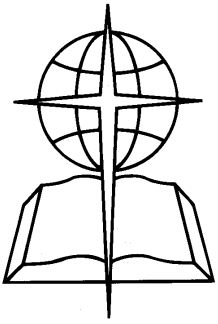
Article IX - Board of Directors

Section 1: The Association shall have a Board of Directors composed of nine members. Six members are to be elected at the annual meeting and serve, along with the moderator, associate moderator and the treasurer, as the Board of Directors. The Director of Missions shall serve as an ex-officio member. The (six) directors are to be elected on a rotating basis, as provided in section 3 of this article.

Section 2: The members of the Board of Directors must be members of churches within the Association, in good standing, and recognized for their knowledge and their loyalty to the programs of the Association.

Section 3: The members of the Board of Directors shall be elected on a rotating basis, provided that in no case shall any person serve on the board longer than three years in succession. The first six members of the Board of Directors shall be elected as follows: two to serve three years; two to serve two years; and two to serve one year, and thereafter two Directors shall be elected at the annual meeting of the McMinn-Meigs Association of Baptists, Inc. to serve three years. Vacancies created by death, resignation or removal from the Associational territory shall be filled at the next annual meeting following the creation of such vacancy by election of a Director to serve the unexpired term. Any person having served on the Board of Directors for a period of three years shall be eligible for re-election after a period of one year.

Section 4: The duty of the Board of Directors shall be to represent the Association in all legal matters and in such other matters as the Association or Executive Board directs, particularly as the real property owned by the Association, protecting the Association, where any process of law is required. Said Board may take such action as to the property holdings of the Association in the interim between the annual meetings, as the Board's discretion may be required or seem necessary or

advisable, except that said Board may not take any action in direct conflict with the policy or direction of the Association or Executive Committee. The moderator of the Association shall serve as President of the Board.

Article X – Committees and Functional Directors

Section 1: The Association shall also maintain the following Standing Committees and Functional Directors, categorized by function as Administrative, Ministry/Missions/Evangelism and Education/Resources as follows:

- A. **ADMINISTRATIVE:** Committee on Committees, Credentials Committee, Executive Committee, Nominating Committee, Personnel Committee, Property and Grounds Committee, Stewardship Committee and Resolutions/Bylaw Director.
- B. **MINISTRY/MISSIONS/EVANGELISM:** Evangelism Committee, Missions Committee, Christian Builders Director, Prayer Ministry Director and WMU Director.
- C. **EDUCATION/RESOURCES:** Media Library Director, Christian Education Director, VBS Director, Bible Drill Director, Seminary Extension Director and Baptist Collegiate Ministries (BCM) Director.

Section 2: The Committee on Committees shall be composed of three persons. The duties of this Committee shall be to recommend for election, at the following Annual Meeting, the members of the Standing Committees named in Article X, Section 1, with the exception of the Committee on Committees.

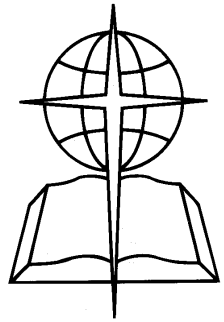
Section 3: Each of said standing committees, with the exception of the Committee on Committees, shall be composed of not less than three but not more than nine members. Members of these committees shall be rotating members and shall be selected from the membership of those churches affiliated with the Association, and shall be subject to reappointment, provided that in no case shall any person serve on the same committee longer than three years in succession, and provided that no person shall serve concurrently on more than two committees, except ex-officio members of all standing committees, including the Committee on Committees.

Article XI – Parliamentary Authority

The parliamentary authority of the McMinn-Meigs Association of Baptists, Inc. shall be the rules contained in the current edition of Roberts Rules of Order newly revised in all matters that are not consistent with these Bylaws and any special rules of order the Association may adopt.

Article XII – Amendments

These By-laws may be amended at any annual meeting, two-thirds of the members present, and voting, concurring providing at least 14 days written notice has been given to the member churches.

Officer, Organization Director and Committee Procedures

The following is information regarding the officers and standing committees of the McMinn-Meigs Association of Baptists, Inc.:

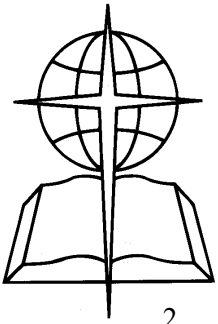
1. Officers are elected on an annual basis and all, except the Moderator and Associate Moderator, may succeed themselves on an annual basis.
2. The Nominating Committee of the Association shall recommend a list of officers and members of the Committee on Committees to the Executive Committee for approval at their third quarterly (July) meeting.
3. All officers and the nominated Committee on Committees shall assume their duties following the next Annual Meeting. However they can, between the Executive Committee July Meeting and the Annual Meeting, recommend, to the Committee on Committees, names of people to serve with them in their area of responsibility.
4. The Nominating Committee shall identify one person for the office of Moderator and one person for the office of Associate Moderator to be recommended for election at the annual meeting. The floor shall be open for additional nominees for the offices of Moderator and/or Associate Moderator, during the annual meeting. The Moderator and Associate Moderator shall assume their duties immediately following the conclusion of the Annual Meeting at which they are elected.
5. The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee and the Committee on Committees.
6. Association organizations and committees named herein shall make written and/or verbal reports to the regular meetings of the Executive Committee and the Association Annual Meeting. The Executive Committee shall exercise authority over these organizations and committees only to the extent of determining whether they are working within the bounds of organizational structure of the Association.

Association Officers and Organization Directors

The following is a description of the duties of the Association officers and organization directors. These Officers and directors are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

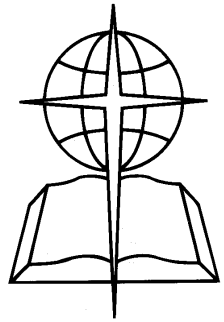
1. **Director of Missions** – The Director of Missions (DoM) is one of five paid employees of the Association (DoM, Secretary, BCM director, camp Director, and Caretaker) and has the responsibility for giving general direction to the paid staff and volunteer leadership of the Association. He is to serve as an ex-officio member of all committees, giving direction as needed and necessary, train the Association leadership in regard to their duties as a committee or organization and help to cast a vision as to the future direction of the Association. A more extensive list of ministry duties can be found in the Job Description Section of the Association Policy Manual.

2. **Moderator** – The Moderator shall preside at all meetings of the Association and shall serve as ex-officio member of all committees and organizations of the Association. The Moderator shall appoint a parliamentarian at any business meeting where the Bylaws Director is absent, and attend to such other duties as the office may require. The Moderator shall work closely with the Director of Missions in all matters of business and future plans (see Association By-laws Article VIII, Section 1).
3. **Associate Moderator** – The Associate Moderator shall be available to assume the duties of Moderator at any time the Moderator cannot fulfill said duties. He also shall serve as ex-officio member of all committees and organizations of the Association (see Association By-laws Article VIII, Section 1).
4. **Association Clerk/ Financial Secretary/Treasurer** – This person shall be a full-time employee of the association serving under the direct supervision of the Director of Missions. She/he shall be responsible for all duties as assigned and shall also serve as office receptionist. She/he shall also serve as the Association Clerk and be an ex-officio member of the Executive Committee and other organizations and committees as is necessary for her/him to attend. She/he shall be responsible for taking minutes (or making sure someone is present to fulfill that duty) at all Executive Committee meetings and at the Annual Meeting of the Association transcribing and distributing such to the proper persons. She/he is charged with maintaining accurate financial records and reporting. This person shall also serve as ex-officio member of the Stewardship Committee. See Job Descriptions for a more extensive detail of duties.
5. **Camp Cherokee Director** – shall have the responsibility of giving overall direction to the operation of the camp. This person shall keep the Association informed of the needs, schedule and vision for the camp. This person shall work closely with Camp Cherokee Committee in developing a maintenance schedule, usage schedule, fund raising system, and developing a vision for the camp. This person shall work closely with the Director of Missions and other key leaders keeping people informed about the ministry of the camp. This is a paid position (part time).
6. **Resolutions/Bylaws Director** – has the responsibility to oversee the Association Bylaws, proposing amendments as deemed necessary and preparing resolutions for association adoption as appropriate. The Director shall enlist other association members to serve as a committee as necessary for the fulfillment of this responsibility. This individual shall serve as the Association Parliamentarian for all Association meetings.
7. **The Board of Directors** – shall serve as the trustees (legal agents) for the Incorporated Association. This board is composed of nine members, six of which are elected annually on a rotating basis (two elected each year) at the Association Annual meeting. The other three members are the Moderator, Associate Moderator and Treasurer. The Director of Missions shall serve as ex-officio member.
8. **Stewardship Director**—shall be the chairman of the Stewardship Committee and shall give direction to the Association’s stewardship of that which is received from our churches and other sources. This person and the committee shall also be available to our churches to help them with any stewardship needs they might have (developing a budget, organizing a stewardship campaign and other stewardship related matters as requested).

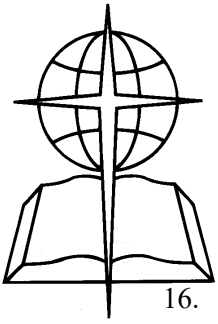

B. MINISTRY/MISSIONS/EVANGELISM

9. **Evangelism Director** – shall serve as chairman of the Evangelism Committee. Along with the committee this person shall work to keep the Association focused on the main thing, reaching people with the Gospel of Christ. This person and the committee shall encourage our churches, through a variety of means, to be evangelistic in seeking to reach their community and beyond. They shall be available to our churches to assist them in developing ministries that are evangelistic in focus that they might be more effective in their outreach efforts. They shall also be charged with the development and implementation of an annual Association-wide Evangelism Rally.
10. **Missions Director** – shall serve as the chairman of the Missions Committee and shall lead this committee in the responsibility for the development of the mission strategy for the Association.
11. **Woman’s Missionary Union (WMU) Director** – shall give general overall direction to the ministry of the WMU of the Association. She shall lead the WMU Council in planning various ministry/mission related events and shall, along with her leaders, be available to our churches to help them develop and/or strengthen their church’s WMU ministry. She and her team shall also keep the Association focused on missions through continuous mission education of children and adults. She shall work with the Director of Missions and the Association Missions Committee in casting a continuous mission involvement vision before the Association.
12. **Prayer Ministry Director** – shall, in conjunction with the Association Prayer Council, be responsible for developing an overall ministry of prayer for the Association. Through encouragement and hands on leadership this person is available to our churches to assist them in establishing an ongoing prayer ministry in their church. This person would, when needed, form ad hoc committees to address special prayer needs as they arise.
13. **Christian Builders Director** – shall serve as chairman of the Christian Builders Committee, coordinating the activities and projects of this committee, leading in outreach from our association to individuals and groups where the Christian Builders can minister through the use of their construction skills.

C. EDUCATION/RESOURCES

14. **Media Library Director** – shall be responsible for maintaining and updating the Media/Resource Center at the Association Baptist Center and shall be available to our churches to help them develop and/or strengthen their existing Media ministry.
15. **Christian Education Director** - shall be responsible for keeping our churches informed of the current trends in Sunday School ministry through correspondence, meetings and other means. This person shall also develop a team of leaders that would be available to go to churches to assist them in all areas of Sunday School ministry. Additionally, shall be responsible for keeping our churches informed of the latest trends in the area of Discipleship Training. This person shall also build a team of age group leaders specifically focused on leadership development in the area of Discipleship Training. This person and his/her team of leaders should be available to go to churches to help them develop and/or strengthen their Discipleship ministry. Further, this person shall oversee all areas of continuing education provided in and through the Association.

16. **Vacation Bible School Director(s)** – shall be responsible for organizing and coordinating the annual Association VBS Training Clinic. The Director(s) shall organize their leadership team and assure they are properly trained for the performance of their duties. The VBS Director(s) shall be available to serve as VBS consultants for the Association churches as requested.
17. **Bible Drill Director** – shall coordinate all events related to the Association Bible Drill Ministry. This person shall set a date, secure a location, contact participating churches, secure judges and callers for the Association event. This person shall do everything possible to get the word about Bible Drill to our churches and encourage them to provide the opportunity for their children and youth to be participants.
18. **Seminary Extension Director** – The Director of Missions shall serve as the Seminary Extension Director. He shall employ a teacher who has the responsibility of teaching two to three classes per year, recruiting students and helping them to set the curriculum for the year. This person is paid a fee per class taught.
19. **Baptist Collegiate Ministries (BCM) Director – Baptist Collegiate Ministries (BCM) Director** – receives a small stipend from the Association and shall be responsible for coordinating the ministry of the BCM ministry at Tennessee Wesleyan College in Athens, TN. This individual shall be employed and paid, in addition to the stipend mentioned above, by the Association with funds received from the Tennessee Baptist Convention and will function under the direction and supervision of the Association. Should the funds cease to be provided by the Tennessee Baptist Convention, the position will be terminated.

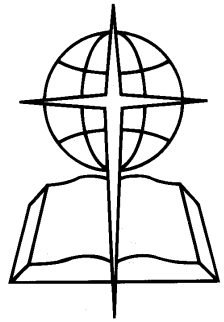
ASSOCIATION COMMITTEES

DESCRIPTION OF DUTIES AND COMMITTEE COMPOSITION

The following is the list of Association Standing Committees and their duties and composition. These Committees are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

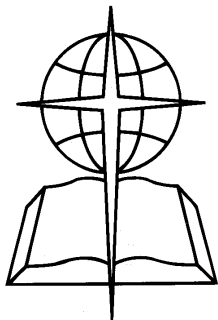
1. **Committee on Committees** – The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee. Members of the Committee on Committees shall serve for one year only and may not serve consecutive terms.
2. **Credentials Committee** – shall receive and consider all applications from churches seeking membership in the Association. They shall study carefully the doctrines, practices and organization of each church seeking membership. They shall determine if said churches are in good standing with their sister churches. Their findings shall be conveyed to the Association at its next annual meeting from the time of application. It shall also be the responsibility of this committee to visit and advise any church of the Association which is reported to have departed from the doctrines and practices of the Association as set forth under Article II and III of the By-laws of this Association. Their findings and recommendations shall be reported at the next annual meeting of the Association. This rotating committee shall be composed of three members.

3. **Executive Committee** – shall consist of the following: one lay member from each member church; the Director of Missions, all organizations directors and committee chairmen and all Pastors of member churches. The Moderator, Associate Moderator, Clerk and Treasurer shall be ex-officio members of the Executive Committee. The committee shall meet quarterly at the Baptist Center, 350 N. Congress Parkway, Athens, Tennessee, or at another location as determined. The annual meeting of the Association shall be considered as the fourth quarter meeting of the Executive Committee. The Moderator has the discretion to call special meetings of the Executive Committee, as needed. Twenty members representing a minimum of 10 churches of the Executive Committee present and voting shall constitute a quorum. The Executive Committee shall be charged with the care of the interests of the Association in the interim between annual meetings. Other duties of the Executive Committee can be found in Article IX Sections 1-5 of the Association By-laws. The following shall be considered the guidelines for the conducting of Association Executive Committee and Annual meetings:
 - 1) A place shall be made on the Order of Business of the Executive Committee and Association Annual Meeting for miscellaneous business.
 - 2) One sermon shall be provided at each Association Annual Meeting
 - 3) The Moderator shall take the chair at the time to which the Association stood adjourned. The Executive Committee and Annual Meetings shall be opened and closed with prayer.
 - 4) The Moderator shall preside over the deliberations of the body, and see that good order is preserved, calling to order if necessary, and reminding members of their duty.
 - 5) Any member wishing to address the Association shall rise in his/her place, and address the Moderator. If more than one seems to address him at one time, he shall name the member to occupy the floor.
 - 6) The Moderator shall decide points of order, subject to an appeal from his decision to the Association. He shall have the preference to speak or explain when an appeal is taken from his decision.
 - 7) Any member may call for a point of order, and the member so-called shall take his seat until the one who made the call shall have time to make their point clear and distinct, and then shall be open for debates and explanations. No person shall speak more than once to any point of order except by leave of the association.
 - 8) The Moderator may name any member to fill the chair, but such substitutions shall not extend beyond adjournment; no motion shall claim his attention unless it is seconded, or shall be open for discussion until formally announced by him.
 - 9) The order of business of the Association shall be such as shall be adopted from time to time by the Association, and shall be subject to change or amendment at the pleasure of the Association.
4. **Nominating Committee** - Shall present, at the July meeting of the Executive Committee, nominations for the Board of Directors and Association officers (see Association Bylaws, Article IX, Section 1) and the Committee on Committees. This

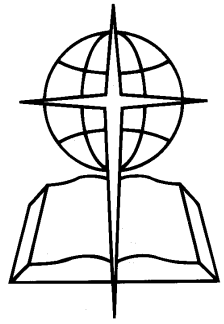

committee shall also present, at the annual meeting, one nomination for the position of Moderator and one nomination for the position of Associate Moderator for election at the annual meeting. This rotating committee shall be composed of three members.

5. **Personnel Committee** – shall recommend staff personnel to fill vacancies occurring during the Association year, and recommend a person or persons to be added to the present staff, at such time as the Association may direct additional personnel to be employed. The committee shall have the power to recommend salaries, define vacations, hear grievances, act on fringe benefits, accept resignations and define the duties of employees. This rotating committee shall be composed of three members.
6. **Property and Grounds Committee** – shall be responsible for maintaining in good repair all equipment, buildings and properties of the Association, except Camp Cherokee, which shall be under the supervision of the Camp Cherokee Committee. This rotating committee shall be composed of three members.
7. **Stewardship Committee** – shall prepare annually a proposed budget for the Association and present such to the annual meeting for adoption. They shall be available to our churches to help them develop methods of supporting the budget. They shall consider all matters of finances referred to it by the Association, Board of Directors and the Executive Committee. They shall also give general supervision to the entire Association finance program, including current operational expenses, financial obligations assumed by the Association and planning and direction in regard to all capital needs and capital investments of the Association. The Treasurer shall be an ex-officio member of this committee. They shall be responsible for auditing all financial records of the Association and obtaining periodic independent audits. This rotating committee shall be composed of six members with the Stewardship Director serving as chairman.

B. MINISTRY/MISSIONS/EVANGELISM

8. **Evangelism Committee** – shall be charged with the responsibility of motivating and encouraging our churches in the area of evangelism. This is done by providing opportunities for our churches to learn of new methods in the area of evangelistic outreach, providing training sessions, organizing and conducting an annual evangelism conference, crusades and encouraging churches to reach new people and bring them into the church through baptism. This rotating committee shall be composed of three members with the Evangelism Director serving as Chairman.
9. **Missions Committee** – shall have the responsibility for the development of the mission strategy for the Association. They shall look at the various needs that exist in the area and develop ministries to meet those needs. They shall also focus on other mission opportunities outside the Association determining the direction the Association will take in the area of International and North American mission volunteerism. Determine the local ministries that the Association needs to develop or support and lead our churches and individuals to be involved. Determine methods that can be used to support and encourage continuing mission education in our churches. This rotating committee shall be composed of six-nine members with the Director of Missions, Moderator, Associate Moderator, and WMU Director serving as ex-officio members.
10. **Christian Builders Committee** – shall have the responsibility to answer the call of individuals and groups where the Christian Builders can minister through the use of their



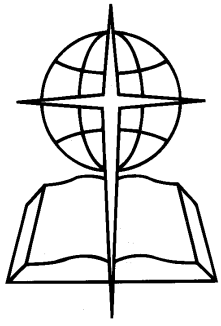

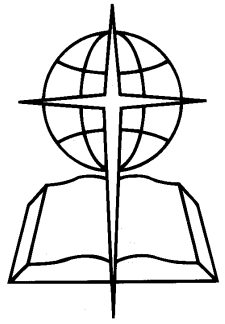

construction skills. This committee shall consist of six to nine members recommended by the Christian Builders Director who shall serve as Chairman of this committee.

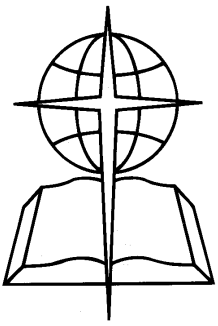
C. EDUCATION/RESOURCES
