The Seminary Extension at McMinn-Meigs Baptist Center is continuing to press forward and using all available technology including electronic classroom systems, social media/Facebook Live, and ZOOM meetings to continue the learning process. God has truly blessed our efforts and our students continue to excel academically and spiritually. This year, our students have completed the following courses:

In the *Fall/Winter Session*, our students completed "<u>Old Testament Survey Part II</u>," using Paul R. House & Eric Mitchell's Old <u>Testament Survey</u>, <u>2nd Edition</u> and Andrew E. Hill & John H. Walton's <u>A Survey of the Old Testament</u>. This course was a survey of the Prophetic Books of the Old Testament (Isaiah through Malachi) as well as miscellaneous books known as the "Writings" (Psalms, Job, Proverbs, Ruth, Song of Songs, Ecclesiastes, Lamentations, Esther, Daniel, Ezra, Nehemiah, and 1st & 2nd Chronicles).

In the *Spring Session*, our students completed "<u>Pastoral Care</u>," using David W. Wiersbe's <u>The Dynamics of Pastoral Care</u>, and Erwin Lutzer's <u>Pastor to Pastor</u> (Revised and Expanded). This course was a study of the work of the Pastor as "Shepherd of the Flock." The focus of this

study was on Counseling, Comforting, Worship Leadership, and Conflict Resolution.

We are in the *Summer/Fall Session*, and studying "<u>Disciplines of Discipleship</u>," using W. Edward Thiele's Fruitful <u>Discipleship</u>. This is a course in "*Spiritual Disciplines*," valuable to the growing Christian, with a focus on the implementation of these Disciplines in the Christian's life. The major headings included: God's Goal and Our Desire; God's Provision and Our Cooperation; God's Expectations and our Challenge. The Auther's desire was for "...the student to have a thorough grasp of what it means to be a Disciple of Jesus," and "to be prepared to introduce others to their Lord and Savior," as well as "assisting them in their growth as Christians."

We have one student graduating upon completion of the Summer/Fall Session.

CHRISTIAN BUILDERS OF SOUTHEAST TENNESSEE

Scott Duckworth, Christian Builders Director

Greetings to our McMinn-Meigs Baptists from Christian Builders.

In this last year, we have had some challenging events. Due to the number of ramps built last year in our area, and across Tennessee, our grant provider fell behind on reimbursements to Hiwassee Builders. This was a sum of several thousands of dollars. We were forced to shut down for a while of building ramps in the grant program. The total amount owed has now been fully paid, and we are now accepting ramps in the grant program again. This did not in any way affect Christian Builders in house funds, and we still did build 9 ramps and did a couple of rail jobs and one re-floor of an existing ramp. Most of these were done with the client paying for the materials, and Christian Builders doing the labor for free. Also, there were not as many calls for ramps to be built. Christian Builders believes that we are to be benevolent in our money, so some of the jobs we did this past year, as in other years, were done with us paying the cost of the materials. We examine the client's ability to pay, and their medical and other costs, to determine what we should do. While Christian Builders funds on hand are in better shape than in years past, I still want to challenge our churches to give \$100 each per year to Christian Builders. Many are giving the \$100, and some have given more. We also accept donations from individuals. We do not receive part of the line -item budget from McMinn-Meigs Baptists. We really do need more volunteers. A lot of our folks are older, and the same ones come time and time again to the jobs. We need some fresh blood. If you can carry a board, we can use you. If you know how to run a saw or nail gun, we can use you. If you have a PHDD (post hole digger degree) we can use you!Lastly, please keep all of our clients, past, current and future in your prayers. Many times as I go to interview these people, they are dealing with medical issues, in pain, and depressed. Some tell me they used to go to church, but now due to their disability, they can't. And, they feel like their church forgot them. They need our churches to reach out to them. They are your neighbors.

You can still participate if you would like to. It is an ongoing project for Wycliffe Bible Translators.

The Missions Committee also set out to have the Association keep a supply of Bibles on hand for distribution. If your church needs some Bibles to give out please let us know. Yes, there are people who live close by who do not have a Bible.

We had two community revivals during the year. They were well attended and a number of different churches were involved. I want to thank First Baptist Church, Athens, and Mount Harmony Baptist Church, Riceville, for hosting these events. It is good to be reminded that the church down the road is family not our competition.

I am thankful for the faithful giving and work of the churches in our association. We are blessed to have churches and pastors seeking to do Kingdom work. God's work is not always easy. There are many challenges, as there are many blessings. Keep pushing forward. You may not think you are getting anywhere, but then you will look up and see that you are not where you were. 



The full financial report for the 2022-2023 year is on pages 3-5. We have finally seen the trend reverse. For the first time in several years, we have exceeded our budget for the year. Our total church receipts to the general fund for this year was \$179,414.93. This is an increase of almost \$25,000 from last year. Our expenses were \$156,916.70. Our expenses were down significantly compared to the previous year. Our ending General Fund balance was up over \$27,200 from the start of our church year. God has blessed us greatly this year.

The proposed budget for next year is on page 6. The committee is recommending a budget of \$166,100. The Stewardship committee has tried each year to keep the budget in line with our income. This year's budget reflects a decrease of over 3% from the past year. We appreciate the faithful giving our churches during this year.



Our Baptist Village Humboldt ministry remains in the construction phase. We had high hopes of finishing the first phase that includes the first two duplex units by the spring of 2023. However, there have been various issues, mostly related to the availability of building supplies, that have caused some significant delays. So, we are a bit cautious about making predictions about when this ministry will be available. That said, we have a measured degree of confidence that these first two duplexes will be completed before the end of 2023. When the entire Baptist Village Humboldt project is completed, there will be 10 duplexes serving 20 financially needy retired pastors and missionaries. The SOAR fund (Supplying Ongoing Aid to Residents) that was established through the Tennessee Baptist Foundation in 2019 has suffered significant losses, just as all investments everywhere over these past four years. Because of these investment losses and the rate of inflation over the past 2 years, we were forced to invade the SOAR fund in order to keep operating our group homes and to continue our development of Baptist Village Humboldt. Our financial losses, since the dissolution of our nursing home about 8 years ago, have placed us in a position of needing additional funding in the very near future. This circumstance has created the need for us to seek additional funding from the Cooperative Program. Your gifts to the Cooperative Program and to the Father's Day Offering will allow us to stop spending our quickly dwindling reserves and to continue providing a Christian home for the men and women in our six group homes.

Speaking of our Father's Day Offering, receipts are pretty much on target to come in at a rate consistent with previous years. Now more than ever, however, we are hopeful that we will far surpass previous years and even exceed our goal. Again, exceeding our FDO goal along with an increase in Cooperative Program funding will allow us to avoid using any further reserves.

We reported last year that after having to cancel Special Friends Camp for three years in a row (2020-2021-2022) due to our inability to find Counselors. The result of those cancellations is that TBAH has determined that we will not seek to have Special Friends Camp for the foreseeable future and possibly ever again.

Because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling, we have been able to serve nearly 200 children and their families this year. Thank you for your prayers, for your service, and for sharing your financial resources with TBCH. Our ministry operates without the use of government funds. We have chosen to rely on God's provision through His people to supply the resources necessary to meet the needs of the children and families we serve.

In 2022-23 TBCH continues to forge ahead with our "Safe Environment Project." One of the core values that drives our ministry is that we will provide a safe environment for the children we serve. TBCH has made changes throughout the years to fulfill this core value and we are now faced with the need to make the change in our residential care program to individual bedrooms and baths for each resident. Because of what many of our children have experienced or been exposed to, this need becomes more apparent as each year passes.

TBCH is making sacrifices to bring this vision into reality. We are reducing the size of our campuses without reducing the number of children we serve. While liquidated property is helping us put our plans into action we are still in great need of your financial assistance. Thank you to those of you whose churches give faithfully to the Cooperative Program and who also make a direct gift to TBCH through the Mother's Day Offering or through your annual missions offerings. May your tribe increase!

I am asking the Lord for \$30 million to bring all three campuses up to date so that we will be set to care for children in a safe environment for the next 75 years! Did that sentence make you gasp?! Then follow it with this one: "Ah Lord God! Behold, You have made the heavens and the earth by Your great power and by Your outstretched arm! Nothing is too difficult for You" (Jeremiah 32:17). We sense strongly that this is the Lord's direction for us to take and we are trusting Him to make a way. If you have questions about the "Safe Environment Project" and how you can be a part of it, I would love to have a conversation with you!

Since 1891, thousands of children's lives have been changed through the ministry of TBCH. We invite you to rejoice with us over the 63 children who found safe homes on our three campuses this fiscal year, along with 133 in our foster homes across the state, 19 reunifications, 14 adoptions, and especially the seven who said YES to Christ. Tennessee WMU encourages and equips churches and individuals to engage in missions learning and involvement that enables them to fulfill the Great Commission. This report shares information about some of the state events, ministries, and initiatives that have taken place.

In September 2022, WMU began a four-year Project HELP: Mental Health emphasis to raise awareness of this important issue and equip members to lead and champion mental health initiatives in the church and local communities.

Three high school students were chosen to serve on the 2022-23 Tennessee Youth Venture Team – Lydia Nakamine and Emma Henley from Red Bank Baptist in Chattanooga and Jacob Murray from Silver Springs Baptist in Mt. Juliet. The students participated in a team retreat and bi-monthly virtual meetings for discipleship, mentoring, and missional study.

Tennessee WMU produced the *SPORTS JAM* missions event kit for children in grades 1-6 with plans, ideas, tips, and instructions to help churches host a missions event for the children in their church or community. The event kit included a Bible lesson, missions lesson highlighting IMB missionaries in Spain, and suggestions for crafts, games, and mission projects.

The 2022 Connection was held at FBC Sevierville on September 30 – October 2 and had 87 youth girls and leaders representing 11 churches in attendance. The event featured Bible study leader Amy-Jo Girardier, IMB missionary speaker Amy Jones from Germany, and local missionaries Jodie Lamon and Melanie Hart reaching internationals in Pigeon Forge and Gatlinburg.

RA Camp-o-Ree celebrated its 50th anniversary on October 14-16, 2022, at Linden Valley Baptist Conference Center with over 350 boys, leaders, and personnel in attendance. This missions camping event for boys grades 1-12 is hosted by Mid-South Royal Ambassadors and Tennessee WMU.

The 2023 Missions Get-Together was held at Brentwood Baptist Church on March 16-18, with a total attendance of 644 people representing over 132 churches. The event featured Bible study leader Mary Wiley and national WMU executive director Sandy Wisdom-Martin. Participants brought over 77,000 items for Christian Job Corps sites in Tennessee through the event ministry project. \$18,814.79 was given through the event **missions offering benefiting** the We Must Have a Place/Linden Valley Village Project (90%) and the TN WMU Touch Tomorrow Today Endowment (10%),

Tennessee WMU awarded \$39,100 in scholarships to 42 students attending graduate school, seminary, and undergraduate schools in Tennessee during the 2023-24 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

Christian Job Corps is a ministry of WMU that seeks to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. There are currently 19 Tennessee CJC sites - 14 Christian Women's Job Corps and five Christian Men's Job Corps.

BAPTIST MEMORIAL HEALTH CARE SYSTEM MEMPHIS, TENNESSEE

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi, and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough - at one point, it almost closed - but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way. The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee, and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist. Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines. The Rev. Jimmy Terry Preaching Series, hosted by Baptist's Pastoral Care Department, observed its sixth anniversary this year. The series, named in memory of a beloved member of Baptist's Board of Trustees and the founder of Tabernacle Baptist Church in Clarksville, Tennessee, welcomes a speaker - usually an ordained Baptist minister - each month to deliver an evangelical message to employees, physicians, patients and visitors from Baptist's flagship hospital. The message is broadcasted live to all 22 Baptist hospitals. Video recordings of each event on our Facebook page have been viewed more than 166,900 times and have reached 170,300 people in the past year. In January, Baptist Memorial Health Care celebrated the grand opening of our new Baptist Arlington Emergency Department in Arlington, Tennessee. The \$16 million facility measures 35,000 square feet and offers eight patient rooms and CT scan, X-ray and ultrasound imaging technology. A Baptist Medical Group primary care office, an imaging center and a helipad are also located on the campus.

Baptist Health Sciences University welcomed newly named president Hampton Hopkins, Ed.D., who will oversee the opening of the university's new College of Osteopathic Medicine, which earned pre-accreditation this year. It's the first school of its kind in the Mid-South and will welcome its first class of medical students for the 2024-25 academic year. A special event to commemorate the beginning of construction on the Baptist University College of Osteopathic Medicine building took place in June, during which a Bible was placed in a capsule in the facility's foundation. Baptist played a significant role in the aftermath of a destructive tornado in Tipton County in March. Despite damage to Baptist Memorial Hospital-Tipton's roof and canopy, and personal property damage and loss for many of our team members, the staff at Baptist Tipton performed heroically, even delivering a baby during the storm. Baptist Ambulance provided 911 ambulance service and routed ambulances from nearby counties to help with the disaster response. In April, Baptist held a dedication and ribbon cutting for Dorothy's Cottage, a 4,100-square-foot expansion of Baptist Centers for Good Grief. Named in honor of Dorothy Lee Wilson, wife of Holiday Inn founder and entrepreneur Kemmons Wilson, Dorothy's Cottage provides a safe environment for grieving children, teens and adults to explore and express grief for the loss of a loved one. The Jackson Clinic, one of the largest physician practices of its kind, and Baptist Memorial Health Care held a topping out ceremony and beam signing last July to celebrate a major milestone for a new outpatient medical campus in Jackson, Tennessee. The event marked the placement of the topmost beam on a 134,966-square-foot, \$62 million, two-story medical office building, which will be located on the campus. Baptist will lease approximately 40,000 square feet of the building for an outpatient surgery center that will include eight operating rooms and four procedure rooms. The Jackson Clinic will lease approximately 70,000 square feet and offer diagnostic imaging, laboratory, pharmacy, and specialty services. In January, Baptist Union City celebrated the opening of its new, \$10 million physician office building in Union City, Tennessee. It will serve as the home of the newly named Baptist Medical Group-Women's Health Center of Union City. The clinic has 18 exam rooms, two procedure rooms, two ultrasound suites, a lab, and a large conference room. The Leapfrog Group recently awarded "A" Hospital Safety Grades to Baptist Union City and Baptist Carroll County to recognize their achievements in protecting patients from harm and error in the hospital. Baptist Booneville and Baptist Union City both earned a five-star rating in the Center for Medicare and Medicaid Services' Overall Hospital Quality Star Ratings for 2022. Only 429 hospitals nationwide were given this rating. Baptist Union City was awarded a three-year, \$1.5 million grant by the Health Resources & Services Administration's Rural Public Health Workforce Training Network Program for education, training and employment opportunities for community paramedics/ emergency medical technicians and respiratory therapists. Baptist was also awarded \$5.5 million to expand the critical care unit at Baptist Collierville and received \$3.5 million to purchase an autonomous nursing robot that can be controlled from a central hub at our corporate offices.

For the past thirty years, Tennessee Baptist's accredited Christian boarding and day school has operated as The King's Academy. Students from across the globe are the Academy's most distinctive feature, with over 1,100 students and 101 nations represented since 1935.

The 2022-23 academic year has come to a close and will go down as a very successful year in the lengthy history of The King's Academy. The goal of this associational report is to provide transparent information regarding the state of The Academy, to highlight exciting additions, and clearly communicate what is expected in the coming year.

While no year will ever be perfect, as we have many obstacles to conquer and the fact that we are inherently not perfect, this past year has been successful in providing stability and setting up the successful future of The Academy. As an administrator, I seek to monitor numbers as they are an indicator of our schools' health and growth. Below is a quick look at TKA by the numbers for the 2022-23 academic year:

- 13: TKA was blessed to start the year with a 13% increase in enrollment from the previous year.
- 16: In the spirit of global outreach, we are thrilled to announce that The King's Academy has reached over 16 nations this past year.
- 32: Students who called our Residence Life Program Home (rebuilding the depleted numbers due to Covid-19)
- 35: Number of Love Where We Live (LWWL) projects that served our community.
- 27: This is my favorite number of all. This year 27 students accepted Jesus Christ as their personal Lord and Savior.
- 1,000,000: This represents the faithful amount that has been raised collectively to the Legacy Fund and tuition assistance funds this year. These gifts represent the faithful support of so many.
- 75: The amount of faculty and staff who faithfully poured into our students on a daily basis.
- 1: The audience for which we do what we do: our Lord.

Over the past year, Union University had the opportunity to celebrate its bicentennial and reflect on 200 years of God's faithfulness. What a history! The Lord has provided for Union time and time again and poured out blessing upon blessing as we have equipped thousands of students to serve the church and society. Generations of Union alumni have taken their gospel witness into all the world, making a difference for Christ in their families, their churches, their workplaces, and their communities.



As we have looked back on our past, we have also dreamed about what God will do through Union in the future. Union trustees in December approved a strategic plan entitled *Protinus* that will guide the university's operational goals and planning over the next five years. *Protinus* is a Latin word that means "to move immediately, forward, continuously, uninterruptedly, as from the very first."

Protinus includes four major themes – advancing Christ-centered higher education, pursuing faithful innovation throughout and across campuses, continuing to solidify and develop Union's financial position and enhancing Union's culture of shared life and commitment to one another's flourishing.

Each theme includes several goals for the university to accomplish by 2027. For example, the theme of advancing Christ-centered higher education includes such goals as focusing each department and athletic team on intentional student discipleship and providing leadership to kindred Christ-centered institutions of higher education.

Another goal in the plan is the completion of a comprehensive fundraising campaign. Union launched "Union 200: Tradition. Truth. Transformation." in September with an \$80 million goal. About \$38 million has been given and pledged toward that goal thus far.

Other highlights from the past year:

Plans are underway for a new academic building on campus that will house the McAfee School of Business and the departments of computer science and engineering.


In partnership with the TBMB, Union hosted its first youth apologetics conference, EQUIP!, with more than 260 attendees.

The Union debate team won another national championship, and the Cardinal & Cream was named the best college magazine in the South for the second straight year.

The College of Pharmacy's class of 2022 scored a 92 percent pass rate on the NAPLEX, the highest rate in the state and the 12th highest nationally.

From a dream, to development, to its August 1851 opening, Baptists of this state have been instrumental in the creation and maintenance of Carson-Newman. Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders.

We have had a blessed year at Mossy Creek. Highlights of this past year includes:

- The University entered its second year of a five-year strategic plan entitled "Acorns to Oaks: Pursuing God's Preferred Future," seeing the completion and opening of the Drama and Ted Russell Center, home to C-N's health sciences as the plan's first major project.
- As part of *Acorns to Oaks*, C-N also broke ground on its first student-residential complex in two decades. West Campus Commons is the largest construction project in C-N's history and is slated to open Fall 2024.
- University Board of Trustees approved a new Campus Master Plan that will guide decision-making over the next 20 years regarding construction, renovation and campus experience.
- A new partnership with Morgan County Correction Complex offers selected inmates the opportunity to pursue a Bachelor of Arts in Christian Studies with an emphasis in Ministry Studies. Dr. Phil Young is the new director of the program.
- As part of a new archeology minor, Carson-Newman University, in collaboration with the Hebrew University of Jerusalem and the American Veterans Archaeological Recovery, completed the initial groundbreaking excavation project at the ruins of Herod the Great's majestic desert fortress, Hyrcania.
- Fortune Media Group named C-N as having one of the nation's best online nursing programs (No. 38 in the U.S.). U.S. News & World Report ranked both C-N's nursing and education online programs No. 2 in Tennessee in their respective categories. The University was also named a College of Distinction and a Christian College of Distinction by the organization Colleges of Distinction.
- Partnering with NAMB's GenSend program, C-N students took part in mission trips during the year to such locations as Denver, Los Angeles, New Orleans, Washington, D.C. and Barcelona, Spain.
- University students and staff teamed up with members of TrueLife Church of Jefferson City and Blue Springs Baptist of Rutledge for a mission trip to Honduras. The team of 14 visited schools, and homes, and met with and encouraged missionaries.
- Carson-Newman hosted the 2022 East Tennessee Evangelism Rally, featuring award-winning Christian music artists Nic Gonzales and Jaci Velasquez, as well as guest speaker Dr. Steve Gaines, senior pastor of Bellevue Baptist Church.
- In partnership with Manley Baptist Church, we were grateful that students and staff chose to express public professions of faith in Christ by being baptized in Mossy Creek on C-N's campus during the fall. There were many other public professions of faith who chose to pursue baptism at their home churches instead of in Mossy Creek. We celebrate that life-changing impact of the Gospel that is transforming lives across our campus.

The University presented the annual Ken Sparks Award to pastor, missionary, evangelist and trainer for church planters, Dr. Wade Akins.



What is a Baptist Association?

(An Association is what the churches make it.)

A Baptist Association is a self-governing fellowship of autonomous churches sharing a common faith and active on mission in their setting.

- 1. The churches of an association are free, independent, self-governing, autonomous churches that decide to associate themselves to do certain things together.
- 2. The fellowship of churches involves oneness, shared life, mutuality and koinonia. It is a "family" of churches and a network, in which churches give and receive assistance. The association as a fellowship emphasizes the relationship existing among the churches.
- 3. Sharing a common faith The fellowship of an association is grounded in harmony in faith and practice. Associations differ in regard to the particular doctrinal issues that are important to their fellowship and in regard to the amount of diversity encouraged or tolerated on those issues. Nevertheless, the association, unlike state conventions, is a doctrinally based fellowship.
- 4. Active on mission refers to God's mission for the churches individually and the churches together in association. The first responsibility of each church is to deal with the same question, "What is God's mission for us together?"
- 5. In their setting deals with everything anyone means when he or she says of his or her association, "But I am in a peculiar situation." Every situation is peculiar, that is, unique; and it is in the uniqueness of that situation that an association of churches has a very special responsibility to be on mission. Associations differ from one another in such ways as size; geographical territory; population; cultural, ethnic, religious, socioeconomic and demographic characteristics of the area; number, strength and types of churches; history; relationship to the state convention; and stage of development.
- 6. Self-governing An association is created by the churches and is accountable to those churches through the messengers. An association, like other general bodies of Baptists, (state conventions, Southern Baptist Convention), is self-governing.

A Baptist Association is what the affiliated churches decide to make it. The messengers and executive board members selected by the churches make those basic decisions. The churches decide again what their association will become when they decide what percentage of their church budgets will go to associational missions.

Southern Baptists are committed to Bold Mission Thrust in a general way. You can be a part of what's happening in a specific way through involvement in your church and association.

McMinn-Meigs Association of Baptists, Incorporated

BY-LAWS

Article I – Existence, Purpose and Relationship

- Section 1: The McMinn-Meigs Association of Baptists, Inc. exists because Southern Baptist Churches have chosen to join together in fellowship, evangelism and missions.
- Section 2: The purpose of the McMinn-Meigs Association of Baptists, Inc. is to equip, resource and encourage one another to be faithful Kingdom Servants in obedience to our Lord's Great Commission.
- Section 3: The McMinn-Meigs Association of Baptists, Inc. shall maintain a cooperative relationship with the Tennessee Baptist Convention and the Southern Baptist Convention in a world mission program.

Article II - Voting Body

- Section 1: This Association in session shall be composed of messengers duly elected by the Southern Baptist Churches in McMinn and Meigs Counties who are affiliated with this organization. The affiliated churches shall be those that choose or elect to cooperate with the principles and practices of the Association as set out in the Charter of Incorporation and as herein set out.
- Each church shall be entitled to two messengers and one additional messenger for each fifty members or fraction thereof after the first hundred with a maximum of ten messengers from any one church.
- Any church petitioning for membership in the Association shall make such petition through the Credentials Committee. Each church whose petition is approved by the Association shall then be placed under the watch care of the Association for one full year or until the next annual session of the Association. At that time, and providing the church has proven to be in sympathy and in accord with the tenets and practices of the Association, it shall then, by a majority vote of the association messengers present and voting, become a member in full standing. During the year of watch care, the petitioning church shall have a voice but not a vote in Associational affairs, including the representation on the Executive Committee and messengers to the Association.
- As a condition of membership in the Association, member churches shall subscribe to the Articles of Faith as outlined in Article III. In addition, member churches are strongly encouraged to submit an annual church letter that will provide demographic information on the ministry and health of the church and contribute to the financial support of the Association.

A. Articles of Faith

- 1) If any member of the Executive Committee feels that an affiliated church is in violation of any section of the Articles of Faith, said member should follow the guidelines of Matthew 18:15-17.
- 2) Should members of the Executive Committee, representing a minimum of two affiliated churches, believe that an affiliated church is in violation of the Articles of Faith, said members, after having, individually, followed the provisions of sub-Paragraph a of this Paragraph, shall bring the violation to the attention of the Association Officers. The Association Officers shall direct the Credentials Committee to investigate the charges brought against the member church, following these guidelines:
 - a) The Credentials Committee shall contact the church charged with a violation of the Articles of Faith in an effort to confirm the validity of the charges brought against the member church.
 - b) Should the Credentials Committee confirm the validity of the charges, every effort shall be made to lead the church back into conformance with the Articles of Faith and restore the church to fellowship with the Association.
 - c) Should the efforts of the Credentials Committee outlined herein fail to resolve the issue, the Committee shall present a report along with recommendations concerning membership to the Association at the next annual meeting or a special called meeting of the Association called for the expressed purpose of dealing with this issue. No such action shall be taken without at least 14 days written notice to all affiliated churches.
 - d) A recommendation for the loss of membership from the Credentials Committee shall require a two-thirds majority vote of the messengers present and voting at the meeting in which said recommendation is presented.

B. Re-admission

Any church dropped from the rolls, as a result of Section 4, may thereafter petition for re-admission under all the terms and conditions herein above prescribed for admission of churches to membership.

Section 5:

If any member of the Executive Committee feels that fellowship should be withdrawn from any affiliated church for any reason not listed above, said member should follow the guidelines of Matthew 18:15-17. If it is, thereafter, deemed necessary, by the Association Officers, to withdraw fellowship from any church FOR ANY REASON OTHER THAN THOSE SPECIFIED IN SECTION 4, and to refuse to seat its messengers, such action shall be only by a two-thirds majority vote of those messengers present and voting at any annual meeting or special called meeting of the Association called for this expressed purpose, exclusive of the messengers from the said church. No such action shall be taken without at least 14 days written notice to all affiliated churches.

Article III -Articles of Faith

The currently adopted Southern Baptist Convention version of the Baptist Faith and Message shall be the doctrines adopted by this Association.

Article IV - Authority

- Section 1: The Association is an autonomous body and therefore reserves the right to determine its own policies and direct its own business; it may refuse to seat messengers who are not in fellowship or doctrinal agreement with the body or if the church by whom they are elected is not.
- Section 2: The Association may advise, give counsel, and propose measures to the churches, but shall exercise no power or ecclesiastical jurisdiction over the churches. It shall have power, however, to withdraw fellowship from any church that departs from the doctrines and practices of Baptist Fellowship in accordance with the guidelines of Article II, Section 4.
- Section 3: A church shall be considered a Southern Baptist Church in good fellowship with the Association if said church accepts and follows the Baptist Faith and Message referenced in Article III hereof as well as the conditions identified in Section 2 of this Article.
- Any question concerning fellowship with the churches shall be referred to the Credentials Committee for review in accordance with Article II, Section 4 (A) before presentation to the Association.

Article V – Meetings

- Section 1: The Association shall convene annually in the Fall for the annual business session, unless otherwise fixed by the Association in annual session. The Association may also come together in the spring for an Association Celebration emphasizing Evangelism and Missions in one special event.
- Special Meetings: The Executive Committee of the Association may call the Association into special session at a time and place set by the committee, with the provision that all affiliated churches must be notified in writing at least 14 days before the special meeting, said notice to give the time, place, and purpose of the meeting.
- Section 3: The program for all Meetings shall be planned by the DOM and Association officers with the assistance of an ad hoc committee as necessary.

Article VI - Associational Year

The Associational year shall begin on October first and end on September thirtieth.

Article VII – Officers

Section 1:

The officers of this Association shall be a moderator, an associate moderator, a clerk, a treasurer, and such other officers as may be authorized by the Association. The moderator of the Association shall have the same duties as the president of a corporation is generally understood to have. The moderator and the associate moderator shall not serve for more than one consecutive year, and provided further, that no person shall be eligible for election as moderator until he shall have been a member of the Association for a period of two years. Furthermore, one of the offices, moderator or associate moderator, must be filled by a bivocational minister or a layperson. The retiring associate moderator shall be eligible for election to the officer of moderator. The clerk and the treasurer shall be employees of the Association.

Section 2:

The officers shall be elected at the annual meeting by majority vote of messengers present and voting, and shall take office at the close of the annual meeting. They shall serve until the close of the next annual meeting of the Association, or until their successors are elected and installed, provided, however, that the retiring clerk shall continue in office as association clerk until the completion and publication of the Associational Minutes and completion of any other duties connected with his/her office for the past associational year.

Article VIII - Executive Committee

Section 1:

There shall be an Executive Committee of the Association which shall consist of the following: one lay member elected by each church of the Association from its membership; the Director of Missions, director or chairman of all organizations and committees authorized by the Association; and the pastors of all churches in the Association. The moderator, associate moderator, clerk and treasurer shall be ex-officio members of the Executive Committee. The Executive Committee shall meet quarterly at the Baptist Center, 350 North Congress Parkway, Athens, Tennessee, or at such other place as may be previously determined. The Annual meeting will serve as the meeting for the fourth quarter of the year of the Executive Committee The Executive Committee shall also meet at the call of its chairman. Twenty members of the Committee representing a minimum of 10 member churches shall constitute a quorum necessary to transact business. At its third quarter meeting preceding the Annual Session of the Association, the Executive Committee shall select the director of all organizations which may be authorized by the Association and as nominated by the Nominating Committee. The organizational directors so selected shall take office immediately following the next annual session. However, following the selection by the Executive Committee, the newly selected organizational directors shall be asked to recommend, to the Committee on Committees, the members for their respective committee/organization for the ensuing year.

Section 2:

The pastor of any church organized as a result of a mission operated for not less than two years under the sponsorship of a church affiliated with the Association shall be a special member of the Executive Committee, with voice but no vote, until such times as said church shall have an opportunity to apply for and become affiliated with the Association.

Section 3:

The officers of the Association are to be the officers of the Executive Committee, with the moderator of the association serving as chairman. The officers of the Executive Committee shall meet to plan the agenda for each Executive Committee Meeting. This meeting shall occur with sufficient time to notify the members of the Executive Committee of the pending business for the upcoming meeting.

Section 4:

The purpose of this Committee shall be to care for every interest of the Association and direct its activities in the interim between the annual meetings and shall carry out the policies and will of the Association as so expressed. The Committee shall have power to fill vacancies, as nominated by the Nominating Committee, among the officers of the Association and the Board of Directors or committees which may occur during the year except representatives to the Executive Committee and may authorize the appointment of any special committee deemed needful to carry out its duties.

Section 5:

Nothing outside of or beyond the authority given by the Association to the Executive Committee shall be exercised, unless prior written notice of at least thirty days has been given all of the churches of the Association and the members of the Executive Committee, with the opportunity for any member to present his views to the vote of the Committee.

Article IX - Board of Directors

Section 1:

The Association shall have a Board of Directors composed of nine members. Six members are to be elected at the annual meeting and serve, along with the moderator, associate moderator and the treasurer, as the Board of Directors. The Director of Missions shall serve as an ex-officio member. The (six) directors are to be elected on a rotating basis, as provided in section 3 of this article.

Section 2:


The members of the Board of Directors must be members of churches within the Association, in good standing, and recognized for their knowledge and their loyalty to the programs of the Association.

Section 3:

The members of the Board of Directors shall be elected on a rotating basis, provided that in no case shall any person serve on the board longer than three years in succession. The first six members of the Board of Directors shall be elected as follows: two to serve three years; two to serve two years; and two to serve one year, and thereafter two Directors shall be elected at the annual meeting of the McMinn-Meigs Association of Baptists, Inc. to serve three years. Vacancies created by death, resignation or removal from the Associational territory shall be filled at the next annual meeting following the creation of such vacancy by election of a Director to serve the unexpired term. Any person having served on the Board of Directors for a period of three years shall be eligible for reelection after a period of one year.

Section 4:

The duty of the Board of Directors shall be to represent the Association in all legal matters and in such other matters as the Association or Executive Board directs, particularly as the real property owned by the Association, protecting the Association, where any process of law is required. Said Board may take such action as to the property holdings of the Association in the interim between the annual meetings, as the Board's discretion may be required or seem necessary or

advisable, except that said Board may not take any action in direct conflict with the policy or direction of the Association or Executive Committee. The moderator of the Association shall serve as President of the Board.

Article X – Committees and Functional Directors

Section 1:

The Association shall also maintain the following Standing Committees and Functional Directors, categorized by function as Administrative, Ministry/Missions/Evangelism and Education/Resources as follows:

- A. <u>ADMINISTRATIVE</u>: Committee on Committees, Credentials Committee, Executive Committee, Nominating Committee, Personnel Committee, Property and Grounds Committee, Stewardship Committee and Resolutions/Bylaw Director.
- B. <u>MINISTRY/MISSIONS/EVANGELISM</u>: Evangelism Committee, Missions Committee, Christian Builders Director, Prayer Ministry Director and WMU Director.
- C. <u>EDUCATION/RESOURCES</u>: Media Library Director, Christian Education Director, VBS Director, Bible Drill Director, Seminary Extension Director and Baptist Collegiate Ministries (BCM) Director.

Section 2:

The Committee on Committees shall be composed of three persons. The duties of this Committee shall be to recommend for election, at the following Annual Meeting, the members of the Standing Committees named in Article X, Section 1, with the exception of the Committee on Committees.

Section 3:

Each of said standing committees, with the exception of the Committee on Committees, shall be composed of not less than three but not more than nine members. Members of these committees shall be rotating members and shall be selected from the membership of those churches affiliated with the Association, and shall be subject to reappointment, provided that in no case shall any person serve on the same committee longer than three years in succession, and provided that no person shall serve concurrently on more than two committees, except exofficio members of all standing committees, including the Committee on Committees.

Article XI – Parliamentary Authority

The parliamentary authority of the McMinn-Meigs Association of Baptists, Inc. shall be the rules contained in the current edition of Roberts Rules of Order newly revised in all matters that are not consistent with these Bylaws and any special rules of order the Association may adopt.

Article XII – Amendments

These By-laws may be amended at any annual meeting, two-thirds of the members present, and voting, concurring providing at least 14 days written notice has been given to the member churches.

Officer, Organization Director and Committee Procedures

The following is information regarding the officers and standing committees of the McMinn-Meigs Association of Baptists, Inc.:

- 1. Officers are elected on an annual basis and all, except the Moderator and Associate Moderator, may succeed themselves on an annual basis.
- 2. The Nominating Committee of the Association shall recommend a list of officers and members of the Committee on Committees to the Executive Committee for approval at their third quarterly (July) meeting.
- 3. All officers and the nominated Committee on Committees shall assume their duties following the next Annual Meeting. However they can, between the Executive Committee July Meeting and the Annual Meeting, recommend, to the Committee on Committees, names of people to serve with them in their area of responsibility.
- 4. The Nominating Committee shall identify one person for the office of Moderator and one person for the office of Associate Moderator to be recommended for election at the annual meeting. The floor shall be open for additional nominees for the offices of Moderator and/or Associate Moderator, during the annual meeting. The Moderator and Associate Moderator shall assume their duties immediately following the conclusion of the Annual Meeting at which they are elected.
- 5. The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee and the Committee on Committees.
- 6. Association organizations and committees named herein shall make written and/or verbal reports to the regular meetings of the Executive Committee and the Association Annual Meeting. The Executive Committee shall exercise authority over these organizations and committees only to the extent of determining whether they are working within the bounds of organizational structure of the Association.

Association Officers and Organization Directors

The following is a description of the duties of the Association officers and organization directors. These Officers and directors are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

1. **Director of Missions** – The Director of Missions (DoM) is one of five paid employees of the Association (DoM, Secretary, BCM director, camp Director, and Caretaker) and has the responsibility for giving general direction to the paid staff and volunteer leadership of the Association. He is to serve as an ex-officio member of all committees, giving direction as needed and necessary, train the Association leadership in regard to their duties as a committee or organization and help to cast a vision as to the future direction of the Association. A more extensive list of ministry duties can be found in the Job Description Section of the Association Policy Manual.

- 2. **Moderator** The Moderator shall preside at all meetings of the Association and shall serve as ex-officio member of all committees and organizations of the Association. The Moderator shall appoint a parliamentarian at any business meeting where the Bylaws Director is absent, and attend to such other duties as the office may require. The Moderator shall work closely with the Director of Missions in all matters of business and future plans (see Association Bylaws Article VIII, Section 1).
- 3. **Associate Moderator** The Associate Moderator shall be available to assume the duties of Moderator at any time the Moderator cannot fulfill said duties. He also shall serve as exofficio member of all committees and organizations of the Association (see Association Bylaws Article VIII, Section 1).
- 4. **Association Clerk/ Financial Secretary/Treasurer** This person shall be a full-time employee of the association serving under the direct supervision of the Director of Missions. She/he shall be responsible for all duties as assigned and shall also serve as office receptionist. She/he shall also serve as the Association Clerk and be an ex-officio member of the Executive Committee and other organizations and committees as is necessary for her/him to attend. She/he shall be responsible for taking minutes (or making sure someone is present to fulfill that duty) at all Executive Committee meetings and at the Annual Meeting of the Association transcribing and distributing such to the proper persons. She/he is charged with maintaining accurate financial records and reporting. This person shall also serve as exofficio member of the Stewardship Committee. See Job Descriptions for a more extensive detail of duties.
- 5. Camp Cherokee Director shall have the responsibility of giving overall direction to the operation of the camp. This person shall keep the Association informed of the needs, schedule and vision for the camp. This person shall work closely with Camp Cherokee Committee in developing a maintenance schedule, usage schedule, fund raising system, and developing a vision for the camp. This person shall work closely with the Director of Missions and other key leaders keeping people informed about the ministry of the camp. This is a paid position (part time).
- 6. **Resolutions/Bylaws Director** has the responsibility to oversee the Association Bylaws, proposing amendments as deemed necessary and preparing resolutions for association adoption as appropriate. The Director shall enlist other association members to serve as a committee as necessary for the fulfillment of this responsibility. This individual shall serve as the Association Parliamentarian for all Association meetings.
- 7. **The Board of Directors** shall serve as the trustees (legal agents) for the Incorporated Association. This board is composed of nine members, six of which are elected annually on a rotating basis (two elected each year) at the Association Annual meeting. The other three members are the Moderator, Associate Moderator and Treasurer. The Director of Missions shall serve as ex-officio member.
- 8. **Stewardship Director**—shall be the chairman of the Stewardship Committee and shall give direction to the Association's stewardship of that which is received from our churches and other sources. This person and the committee shall also be available to our churches to help them with any stewardship needs they might have (developing a budget, organizing a stewardship campaign and other stewardship related matters as requested).

B. MINISTRY/MISSIONS/EVANGELISM

- 9. **Evangelism Director** shall serve as chairman of the Evangelism Committee. Along with the committee this person shall work to keep the Association focused on the main thing, reaching people with the Gospel of Christ. This person and the committee shall encourage our churches, through a variety of means, to be evangelistic in seeking to reach their community and beyond. They shall be available to our churches to assist them in developing ministries that are evangelistic in focus that they might be more effective in their outreach efforts. They shall also be charged with the development and implementation of an annual Association-wide Evangelism Rally.
- **10. Missions Director** shall serve as the chairman of the Missions Committee and shall lead this committee in the responsibility for the development of the mission strategy for the Association.
- 11. Woman's Missionary Union (WMU) Director shall give general overall direction to the ministry of the WMU of the Association. She shall lead the WMU Council in planning various ministry/mission related events and shall, along with her leaders, be available to our churches to help them develop and/or strengthen their church's WMU ministry. She and her team shall also keep the Association focused on missions through continuous mission education of children and adults. She shall work with the Director of Missions and the Association Missions Committee in casting a continuous mission involvement vision before the Association.
- 12. **Prayer Ministry Director** shall, in conjunction with the Association Prayer Council, be responsible for developing an overall ministry of prayer for the Association. Through encouragement and hands on leadership this person is available to our churches to assist them in establishing an ongoing prayer ministry in their church. This person would, when needed, form ad hoc committees to address special prayer needs as they arise.
- 13. **Christian Builders Director** shall serve as chairman of the Christian Builders Committee, coordinating the activities and projects of this committee, leading in outreach from our association to individuals and groups where the Christian Builders can minister through the use of their construction skills.

C. EDUCATION/RESOURCES

- 14. **Media Library Director** shall be responsible for maintaining and updating the Media/Resource Center at the Association Baptist Center and shall be available to our churches to help them develop and/or strengthen their existing Media ministry.
- 15. Christian Education Director shall be responsible for keeping our churches informed of the current trends in Sunday School ministry through correspondence, meetings and other means. This person shall also develop a team of leaders that would be available to go to churches to assist them in all areas of Sunday School ministry. Additionally, shall be responsible for keeping our churches informed of the latest trends in the area of Discipleship Training. This person shall also build a team of age group leaders specifically focused on leadership development in the area of Discipleship Training. This person and his/her team of leaders should be available to go to churches to help them develop and/or strengthen their Discipleship ministry. Further, this person shall oversee all areas of continuing education provided in and through the Association.

- 16. Vacation Bible School Director(s) shall be responsible for organizing and coordinating the annual Association VBS Training Clinic. The Director(s) shall organize their leadership team and assure they are properly trained for the performance of their duties. The VBS Director(s) shall be available to serve as VBS consultants for the Association churches as requested.
- 17. **Bible Drill Director** shall coordinate all events related to the Association Bible Drill Ministry. This person shall set a date, secure a location, contact participating churches, secure judges and callers for the Association event. This person shall do everything possible to get the word about Bible Drill to our churches and encourage them to provide the opportunity for their children and youth to be participants.
- 18. **Seminary Extension Director** The Director of Missions shall serve as the Seminary Extension Director. He shall employ a teacher who has the responsibility of teaching two to three classes per year, recruiting students and helping them to set the curriculum for the year. This person is paid a fee per class taught.
- 19. Baptist Collegiate Ministries (BCM) Director Baptist Collegiate Ministries (BCM) Director receives a small stipend from the Association and shall be responsible for coordinating the ministry of the BCM ministry at Tennessee Wesleyan College in Athens, TN. This individual shall be employed and paid, in addition to the stipend mentioned above, by the Association with funds received from the Tennessee Baptist Convention and will function under the direction and supervision of the Association. Should the funds cease to be provided by the Tennessee Baptist Convention, the position will be terminated.

ASSOCIATION COMMITTEES

DESCRIPTION OF DUTIES AND COMMITTEE COMPOSITION

The following is the list of Association Standing Committees and their duties and composition. These Committees are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

- 1. **Committee on Committees** The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee. Members of the Committee on Committees shall serve for one year only and may not serve consecutive terms.
- 2. Credentials Committee shall receive and consider all applications from churches seeking membership in the Association. They shall study carefully the doctrines, practices and organization of each church seeking membership. They shall determine if said churches are in good standing with their sister churches. Their findings shall be conveyed to the Association at its next annual meeting from the time of application. It shall also be the responsibility of this committee to visit and advise any church of the Association which is reported to have departed from the doctrines and practices of the Association as set forth under Article II and III of the By-laws of this Association. Their findings and recommendations shall be reported at the next annual meeting of the Association. This rotating committee shall be composed of three members.

- 3. Executive Committee shall consist of the following: one lay member from each member church; the Director of Missions, all organizations directors and committee chairmen and all Pastors of member churches. The Moderator, Associate Moderator, Clerk and Treasurer shall be ex-officio members of the Executive Committee. The committee shall meet quarterly at the Baptist Center, 350 N. Congress Parkway, Athens, Tennessee, or at another location as determined. The annual meeting of the Association shall be considered as the fourth quarter meeting of the Executive Committee. The Moderator has the discretion to call special meetings of the Executive Committee, as needed. Twenty members representing a minimum of 10 churches of the Executive Committee present and voting shall constitute a quorum. The Executive Committee shall be charged with the care of the interests of the Association in the interim between annual meetings. Other duties of the Executive Committee can be found in Article IX Sections 1-5 of the Association By-laws. The following shall be considered the guidelines for the conducting of Association Executive Committee and Annual meetings:
 - 1) A place shall be made on the Order of Business of the Executive Committee and Association Annual Meeting for miscellaneous business.
 - 2) One sermon shall be provided at each Association Annual Meeting
 - 3) The Moderator shall take the chair at the time to which the Association stood adjourned. The Executive Committee and Annual Meetings shall be opened and closed with prayer.
 - 4) The Moderator shall preside over the deliberations of the body, and see that good order is preserved, calling to order if necessary, and reminding members of their duty.
 - 5) Any member wishing to address the Association shall rise in his/her place, and address the Moderator. If more than one seems to address him at one time, he shall name the member to occupy the floor.
 - 6) The Moderator shall decide points of order, subject to an appeal from his decision to the Association. He shall have the preference to speak or explain when an appeal is taken from his decision.
 - 7) Any member may call for a point of order, and the member so-called shall take his seat until the one who made the call shall have time to make their point clear and distinct, and then shall be open for debates and explanations. No person shall speak more than once to any point of order except by leave of the association.
 - 8) The Moderator may name any member to fill the chair, but such substitutions shall not extend beyond adjournment; no motion shall claim his attention unless it is seconded, or shall be open for discussion until formally announced by him.
 - 9) The order of business of the Association shall be such as shall be adopted from time to time by the Association, and shall be subject to change or amendment at the pleasure of the Association.
- 4. **Nominating Committee** Shall present, at the July meeting of the Executive Committee, nominations for the Board of Directors and Association officers (see Association Bylaws, Article IX, Section 1) and the Committee on Committees. This committee shall also


present, at the annual meeting, one nomination for the position of Moderator and one nomination for the position of Associate Moderator for election at the annual meeting. This rotating committee shall be composed of three members.

- 5. **Personnel Committee** shall recommend staff personnel to fill vacancies occurring during the Association year, and recommend a person or persons to be added to the present staff, at such time as the Association may direct additional personnel to be employed. The committee shall have the power to recommend salaries, define vacations, hear grievances, act on fringe benefits, accept resignations and define the duties of employees. This rotating committee shall be composed of three members.
- 6. **Property and Grounds Committee** shall be responsible for maintaining in good repair all equipment, buildings and properties of the Association, except Camp Cherokee, which shall be under the supervision of the Camp Cherokee Committee. This rotating committee shall be composed of three members.
- 7. Stewardship Committee shall prepare annually a proposed budget for the Association and present such to the annual meeting for adoption. They shall be available to our churches to help them develop methods of supporting the budget. They shall consider all matters of finances referred to it by the Association, Board of Directors and the Executive Committee. They shall also give general supervision to the entire Association finance program, including current operational expenses, financial obligations assumed by the Association and planning and direction in regard to all capital needs and capital investments of the Association. The Treasurer shall be an ex-officio member of this committee. They shall be responsible for auditing all financial records of the Association and obtaining periodic independent audits. This rotating committee shall be composed of six members with the Stewardship Director serving as chairman.

B. MINISTRY/MISSIONS/EVANGELISM

- 8. **Evangelism Committee** shall be charged with the responsibility of motivating and encouraging our churches in the area of evangelism. This is done by providing opportunities for our churches to learn of new methods in the area of evangelistic outreach, providing training sessions, organizing and conducting an annual evangelism conference, crusades and encouraging churches to reach new people and bring them into the church through baptism. This rotating committee shall be composed of three members with the Evangelism Director serving as Chairman.
- 9. **Missions Committee** shall have the responsibility for the development of the mission strategy for the Association. They shall look at the various needs that exist in the area and develop ministries to meet those needs. They shall also focus on other mission opportunities outside the Association determining the direction the Association will take in the area of International and North American mission volunteerism. Determine the local ministries that the Association needs to develop or support and lead our churches and individuals to be involved. Determine methods that can be used to support and encourage continuing mission education in our churches. This rotating committee shall be composed of six-nine members with the Director of Missions, Moderator, Associate Moderator, and WMU Director serving as ex-officio members.
- 10. Christian Builders Committee shall have the responsibility to answer the call of individuals and groups where the Christian Builders can minister through the use of their
